#### TOM SOUL, 837 N 8th

My name is Tom Soul and I am an Allentown resident residing in the 8<sup>th</sup> ward. I have been so situated since 2007. At the last city council meeting, resident observers were made to endure the chattering buzz of radical ideologues parroting two form letters that were likely drafted by an adjunct sociology professor at Muhlenberg college. For nearly two hours, tax payers were forced to listen to the same verbiage, cut, copied and pasted by children receiving extra credit for Xeroxing such drivel. Eight out of ten of these letters were from residents at the 2400 block of Chew street – Muhlenberg College- that I'd add are protected during the semester via extra duty assignments by the very Allentown Police Officers some of them have sought to vilify. It is my sincere hope my letter receives the same attention as did their little homework assignment.

I will not belabor the St. Luke's Hospital incident except to say that; since the last council meeting the District Attorney's Office, after an independent investigation, has decided there would be no charges against the officers and the Allentown Police Department has decided no policies were violated. In the interim, however, it has come to my attention that, at least two City Council Members, Ce-Ce Gerlach and Joshua Siegel, were seen marching with "Black Lives Matter" activists chanting "fuck the police." The obvious impropriety of such behavior on the part of a sitting city council person needs no further discussion. And neither does the 8 second head (NOT NECK!) restraint that was used by the Allentown officer. What is necessary, and I hope you'll permit me, is a closer examination of the underlying ideology that motivated two city council persons to turn their backs on their own police force in the absence of any evidence whatsoever.

For weeks Allentown residents, via a 20 second cell phone clip, were made to believe that one of their own had narrowly dodged the fate of George Floyd, the black man extinguished on the side of the road via nine minutes of asphyxiation in Minnesota. Moving forward, and to provide context for the next use of force incident – and there will be one – it is imperative that these two city council persons are educated about the rarity of a George Floyd and are censured for their deliberate and political misrepresentation of the facts in the Allentown incident. In interest of that...

In 2015 The Washington Post -hardly a bastion of conservatism – began tracking police involved killings in the U.S. There are approximately 330 million citizens in the United States. African Americans make up about 13 percent of that, about 43 million people.

Last year in 2019, according to the Washington Post, **EXACTLY NINE UNARMED** African Americans were killed by police officers and a substantial majority of those nine were actively fighting the officer -who is armed- at the time they were shot. That's .0000021 percent of the population. To say George Floyd -while tragic- was an anomaly would be an understatement. And yet, for two weeks "Black Lives Matter" activists descended on our fine City and were joined by Joshua Siegel and Ce-Ce Gerlach in painting one of our officers as a murderous racist in the total absence of any facts and without the benefit of any review of relevant policies and procedures.

Allentown tax payers should demand immediate censure of Ce-Ce Gerlach and Joshua Siegel and I believe council in its entirety should be forced to review the Black Lives Matter website whereby they will formulate a better understanding of the socialist ideological machine they will be forced to contend with in the coming years. To wit, an excerpt from their own website...

"we disrupt the Western-prescribed nuclear family structure requirement by supporting each other as extended families and "villages" that collectively care for one another, especially our children, to the degree that mothers, parents, and children are comfortable."

Absent – as is the case in so many dysfunctional households regardless of race- is any mention of a father. This is no accident. And neither is their total misrepresentation of the men and women that swear an oath to protect majority minority cities like Allentown. I demand an immediate public apology from both Ce-Ce Gerlach and Joshua Siegel for their reckless conduct and blatant disregard for the safety of Allentown's finest.

I have been a member of the Allentown community for three years now, and have never been so disheartened by the attack on community representation. I strongly oppose Resolution 94. Both council members Gerlach and Siegal are merely listening to the Allentown community, which is the job of city council members in the first place. #### BETTY RIDDLE, 728 S FILMORE

Dear Council,

First, I want to make something abundantly clear: Black lives matter is not a political agenda, it is a human rights issue. Police are killing Black and brown people at alarming rates all across this country, whether or not you personally know somebody who has been killed by police. This is contributing to a systemic genocide that must be examined in every single police department in every city in this country. And it goes above and beyond just the police. This is about 400 years of oppression for which there is no end in sight.

Now that we have cleared that up, shame on you for the attempted censure of Cece Gerlach and Josh Siegel for standing up for human rights. Shame on you for not standing with them and with the citizens who are screaming out for their lives. Shame on you for supporting "back the blue", which is an attack on the Black lives matter movement. Which is an attack on human rights. Allow me to reiterate: "back the blue" arose out of opposition to a marginalized group of people demanding the right to live, demanding to not be killed by police. And we saw two of our very own council members stand with them last week. That is an absolute shame.

Now is the time for all non-POC people living in America to do some deep self reflection and thoroughly examine their privilege. Ask yourself why you stood with the "back the blue" crowd. Is it because you have never felt your stomach drop as a cop car pulls up behind you, worried that you might "fit the description"? Is it because when you watched a police officer kneel on the neck of George Floyd you didn't fear for your life? Is it because when we saw yet another officer kneel on the head and neck of a sick man in Allentown, you didn't cringe at the image of an officer's body weight scraping this man's face into the ground? Is it because you have never considered what it is like living as a person of color in this country? I urge you to ask yourselves these types of questions, and really try to understand something that has never personally affected you.

I don't know how many times I have to say this, but I will keep saying it: we are not asking for a complete dismantling of the police department overnight. We are not here asking for firefighters to replace police officers. We are not here to support the rape and murder of our citizens. You have got to be kidding me. We are not here saying every single police officer is personally corrupt or ill-willed. We are saying there is a systemic problem that is killing people and we need to talk about how to solve it. How can you still not see that? You couldn't even vote last week on whether or not we can have a public conversation?

The attempt to censure CeCe Gerlach and Josh Siegel is an attempt to censure Black lives. This censure is deeply rooted in white supremacy and only goes to show how much work needs to be done right here in Allentown. We have to do better. Council, as community representatives of a majority Black and brown city, you have to do better. You are not listening and now you are attempting to silence us. Ask yourselves why.

Regarding Bill 48, this is a slap in the face to those of us who have been protesting in the streets, calling out for a defunding of the police. Reject the grant. Vote NO. Put this money into the community. If \$10,000 can be allocated to buying new shirts for the police, imagine what effect this money could have on the families in Allentown that are having to choose whether to pay their electric bill or feed their children. Council, please THINK about this. We are in the midst of civil outrage and a global pandemic that is killing Black and brown people disproportionately. And you want to give \$50,000 to the police for uniforms and equipment? Are you serious?

Regarding the APD Advisory Board: I clearly do not have enough time or space to break down everything that is wrong with this proposal. However, if the members of this board are to be appointed by the mayor and approved by city council, how can the community expect to be adequately represented? This draft prohibits any citizen that has a felony or misdemeanor from participating. Aren't those members of the community the ones that have the most valid understanding of how police treat people? Of how effective our criminal justice system is? Again, you are not listening. Take a minute and really try to understand another person's point of view. I am deeply disappointed in this draft resolution and demand that you do better. It is your duty and responsibility to educate yourselves on systemic racism and respond appropriately. This is not it. You have to do better than this. Lives are depending on it.

# JEREMY WARMKESSEL, IAFF

My name is Jeremy Warmkessel. 936 Hawthorn Rd Allentown Pa 18103. President of IAFF Local 302 Allentown Firefighters.

The International Association of Fire Fighters Local 302 would like to address Bill 51 that appears on the agenda this evening directing Lehigh County Board of Elections to place a Home Rule Charter referendum on the ballot in November's election.

Local 302 is of the opinion that the result of these actions will force all contract negotiations into arbitration. The Home Rule Charter is clear, and I believe the framers took into consideration how ACT 111 and all collective bargaining negotiations work. Adding City Council approval at the conclusion of the negotiation is unfair to both City and Bargaining Unit, having no knowledge of evidence or context which led to the settlement they are being presented.

Additionally, Local 302 believes that any discussion held in Council will have to be conducted publicly per Pennsylvania Sunshine Laws and the Homerule Charter. Currently the Mayor has the authority to appoint his negotiating team so a far better option would be to lobby for representation from council on the team or seek a referendum to make it happen.

In conclusion the way the Council is trying to become involved will ultimately be detrimental to the negotiation process. Having a member on the team from the beginning is fairer and more productive. Local 302 nor the City should have to explain a negotiated settlement approved by both parties publicly before a final ratification from City Council (a third party) who was not involved at all.

Councilman Julio Guridy has responded around 50-60% of the time. Councilwoman Cynthia Mota has never once responded to either Julian Kern or myself ever since she has taken office. So again, why is getting a timely response an issue for some Council members.
