AN ORDINANCE

Amending the 2020 Capital Fund Budget by transferring the available balance from Capital Project 1905 – Citywide Parks and Playground Improvements, 2202 – WPA Structures and 2210 – Park Facilities Improvements to Capital Project 2206 – Jordan Creek Greenways Trails and 2213 – Valania Park Renovations in the amount of Ninety-Six Thousand Nine Hundred and Sixty-Five (\$96,965) Dollars to complete the Jordan Creek Greenways Trails and renovations at the Valania Park.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer in the amount of Ninety-Six Thousand Nine Hundred and Sixty-Five (\$96,965) Dollars as follows:
