AN ORDINANCE

Amending the 2020 Capital Fund Budget to provide for a supplemental appropriation of Two Hundred Fifty Thousand (\$250,000) Dollars from the Pennsylvania Department of Conservation and Natural Resources (DCNR) to support the construction phase of Valania Park.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2020 Capital Fund in the amount of Two Hundred Fifty Thousand (\$250,000) Dollars from the Pennsylvania Department of Conservation and Natural Resources.

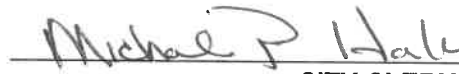
