AN ORDINANCE

Amending the 2020 General Fund Budget to provide for a supplemental appropriation of Fifty Thousand (\$50,000) Dollars from the Pennsylvania Department of Community and Economic Development (DCED) to purchase safety equipment.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2020 General Fund in the amount of Fifty Thousand (\$50,000) Dollars from the Pennsylvania Department of Community and Economic Development.
