AN ORDINANCE

Amending the 2020 General Fund Budget to provide for a supplemental appropriation of One Hundred Fifty Thousand One Hundred Forty-Nine (\$150,149) Dollars from the Pennsylvania Department of Community and Economic Development, Bureau of Public Health Preparedness and Response to the City of Allentown for COVID-19 related expenses. The full grant amount is Two Hundred Sixty-Four Thousand Three Hundred (\$264,300) Dollars with One Hundred Fourteen Thousand One Hundred Fifteen (\$114,151) Dollars remaining in General Fund Revenue to reimburse for existing salaries.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2020 General Fund in the amount of Two Hundred Sixty-Four Thousand Three Hundred (\$264,300) Dollars from the Pennsylvania Department of Community and Economic Development, Bureau of Public Health Preparedness and Response

LEGISLATIVE TEMPLATE

What Department or bureau is Bill originating from? Where did the initiative for the bill originate?

The bill originated from the Department of Community Development, Bureau of Health. A total award of Two hundred and sixty-four thousand, three hundred dollars (\$264,300) was received. One hundred fifty thousand one hundred and forty-nine dollars (\$150,149) in new funds will be allocated from this award from the Pennsylvania Department of Health, Bureau of Public Health Preparedness and Response. The remaining One hundred and fourteen thousand, one hundred fifty-one dollars will be used to offset salaries already budgeted and paid by the general fund.

This is a federally-funded Coronavirus Aid, Relief, and Economic Security (CARES) pass through grant to provide public health departments with resources needed for COVID-19 prevention, mitigation, response and recovery activities in the Public Health Emergency Preparedness grant.

Summary and Facts of the Bill

Amending the 2020 General Fund Budget to provide for a new appropriation one hundred fifty thousand one hundred and forty-nine dollars (\$150,149) in new funds will be allocated from this award from the Pennsylvania Department of Health, Bureau of Public Health Preparedness and Response. The remaining One hundred and fourteen thousand, one hundred and fifty-one dollars (\$114,151) will be used to offset salaries already budgeted and paid by the general fund . This appropriation funds several new positions as well as positions that were changed as a result of the redistribution of job duties as a result of COVID-19 but also to better prepare for public health emergencies of all types in the future.

THIS IS AN EMERGENCY REQUEST. The purpose of the funding is to provide resources and assist in covering expense for the Health Bureau's public health response to coronavirus disease (COVID-19). The specific public health preparedness tasks the bill seeks to accomplish are disease investigation, contact tracing and containment. The systems and roles put in place through this funding are not just COVID specific but build a public health response system that will be useful in mitigating and preventing additional disease outbreaks and enhancing other emergency response activities.

A benefit of this Bill is to enhance Allentown's ability to respond to COVID-19 that is both a global pandemic and an ongoing local public health emergency. There is no down-side to this funding.

This Bill is congruent with the Health Bureau's mission to prevent disease and injury and to protect and promote the public's health.

Passing this Bill will not result in a financial cost to the City. \$150,149 in new expenditures will be placed in the 2020 budget, with corresponding revenues.

The benefits of the appropriation is to reimburse the City of Allentown for expenses related to the public health response to COVID-19.

The funds being allocated will be used to: 1) employ part-time contact tracers to follow up with the contacts of COVID-19 positive City of Allentown cases to prevent the spread of the disease; 2) travel to meetings; 3) secure assistance with response and recovery efforts; 4) implement education and awareness campaigns; and 5) purchase equipment and supplies.6) to cover salary expenses of position changes which are occurring after the 2020 budget was passed.

The funds are also needed to for cell phone costs within the Administration's telephone budget.
