Authorization for a \$125,826 Contract with Michael Baker International, Inc. to provide consulting, planning, and design services for the site analysis, conceptual planning, and design of the proposed MLK Trail Extension Project, 5 bids.

Resolved by the Council of the City of Allentown, That

WHEREAS, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

1. Name of Contractor/Consultant: Michael Baker International, Inc. C
2. Project or Contract Reference: C27-000081 /RFP NO. 2020-17 -MLK Trail Extension
3. Description of Service(s): seek the services of a Contractor to provide detailed consulting, planning, and design services for the site analysis, conceptual planning, and design of the proposed MLK Trail Extension Project. The project will involve the planning, testing, and design of a one-mile minimum 10' wide paved multi-use trail that will extend from the future Auburn Cross Trails Park westward to the Lehigh Parkway linking Center City Allentown with the extensive City and regional trail networks.

- Description of project or scope of services to be provided:

On or about July 27, 2020, the City advertised a solicitation to seek the services of a Contractor to provide detailed consulting, planning, and design services for the site analysis, conceptual planning, and design of the proposed MLK Trail Extension Project. The project will involve the planning, testing, and design of a one-mile minimum 10' wide paved multi-use trail that will extend from the future Auburn Cross Trails Park westward to the Lehigh Parkway linking Center City Allentown with the extensive City and regional trail networks.

August 26, 2020, the public opening was held and the technical proposals were opened from all five (5) vendors. Said proposals were distributed to the committee members and a Technical Evaluation was held on September 2, 2020. After the initial discussion, the committee members scored accordingly based on ability to meet the RFP Requirements. Prior Experience/Team Member Qualifications, Michael Baker had scored the highest.

On September 4, 2020 the cost proposals were opened and distributed to all committee members via Microsoft Teams for future evaluation. The cost evaluation meeting occurred on September 14, 2020 via Microsoft Teams. All committee members were present.

The committee members discussed the cost proposals. The committee then scored proposals based on Cost with 65 points being awarded for cost. Michael Baker had received 64 points for the cost proposal, which was the highest. The Committee made the recommendation to not proceed with Oral interviews/Presentations as they felt confident in deciding with the information provided in the Technical and Cost Proposals and would like to award to Michael Baker International, Inc.

- Contract Term:

The Contract term shall commence upon full execution and shall cease on June 30, 2021. There is a grant associated with this contract, If the said grant (C02-000019) term is extended beyond June 30, 2021, then by and through this Contract term shall be extended to coincide.
