The Cost to replace the bows and the light bulbs in \$7,000 from Account #000-09-0901-0004-46 to Accounts #000-08-0709-0001-54 and 000-08-0709-0001-68 and **\$5,000 in City Council** – Need additional funds for Legal Ads for the remainder of 2020 from Account #000-01-0101-0001-46 (Other Contract Services) to Account #000-01-0101-0001-50 (Other Services & Charges).
