No. <u>132</u> RESOLUTION R - 2020

Introduced by the Administration on November 4, 2020

Authorizes Grant Application to the PennDOT for Eight Hundred Thirty Thousand Seven Hundred Fifty (\$830,750) to support the 15th Street Corridor Lighting Project and Extension.

Resolved by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a Multimodal Transportation Fund Grant in the amount of \$830,750 from the Pennsylvania Department of Transportation to fund improvements to the lighting on the 15th Street corridor and extend the system to Highland Street.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Ray O'Connell, Mayor, and Jessica Baraket, Purchasing Agent, as the official(s) to execute all documents and agreements between the City of Allentown and the Department of Transportation to facilitate and assist in obtaining the requested grant.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for Eight Hundred Thirty Thousand Seven Hundred Fifty Dollars (\$830,750) in Multimodal Transportation Funds to the Department of Transportation.
