Authorizes Submission of an Application to the Pennsylvania Department of Community & Economic Development for a Grant of Two Hundred Ninety-Five Thousand Five Hundred Dollars (\$295,500) to support The Caring Place in conducting renovations to their facility.

Resolved by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a Local Share Account Grant of Two Hundred Ninety-Five Thousand Five Hundred Dollars (\$295,500) from the Pennsylvania Department of Community & Economic Development to fund renovations to the infrastructure of the Caring Place.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Ray O'Connell, Mayor, and the Finance Director as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for Two Hundred Ninety-Five Thousand Five Hundred Dollars (\$295,500) in Local Share Account funds to the Department of Community & Economic Development.
