# HISTORY OF THE STREET PROPOSED TO BE VACATED:

The subject portion of South Fountain Street is in the 3rd Ward. South Fountain Street has a 20' Right of Way established by the Official City Map of Allentown prepared by Aschbach adopted by City Ordinance Volume 1 Page 7 on August 1st, 1867.

The subject portion of School Street is in the 3<sup>rd</sup> Ward. School Street originated from the Property conveyance of Simon Switzer to Northampton Water Co. by Deed Book 16 Page 44, dated September 16, 1852. School street is listed as a Private Alley in some Deeds.

### **LOCATION AND CONDITION:**

The subject portion of South Fountain Street is opened and has existing utilities within the subject Right of Way.

The subject portion of School Street is partially unopened and has existing utilities within the subject Right of Way. Adjoining properties use a portion of the subject School Street for access to the rear of their properties.






