Lehigh Carbon Community College was founded in 1966 and is a public, two-year community college accredited by the Middle States Commission on Higher Education. The community college offers more than 90 diploma, certificate, and associate degree programs through seven schools of study: Business, Science and the Arts, Education, Healthcare Sciences, Humanities and Social Sciences, Mathematics and Science, and Technology. The college has multiple campuses; however, it shares the main 250 acre campus with the Career and Technical Institute. Credit and noncredit student annual enrollment exceeds 14,000 students.

- Championed a partnership for a \$10 million, competitive federal grant to support a three-college consortium providing high priority workforce.
- Led the Middle States Periodic Review in 2018 resulting in accreditation with no recommendations; next accreditation 2026-2027.
