#### AN ORDINANCE

Amending the 2021 General Fund and the 2021 Liquid Fuels Fund budgets by transferring from the unappropriated balance to the Other Contract Services Account in both funds to cover the unexpected cost of hiring contractors to assist with snow removal.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the January 31, 2021 snow storm which brought 27.3" of snow to Allentown necessitated the need to hire contractors to assist with snow removal at a combined total of Two Hundred Sixty-Seven Thousand Six Hundred Sixty-One Dollars and Ninety-Six Cents (\$267,661.96).

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund in the amount of One Hundred Sixty Thousand Five Hundred Ninety-Seven Dollars and Eighteen Cents (\$160,597.18) as follows:

SECTION THREE: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Liquid Fuels Fund in the amount of One Hundred Seven Thousand Sixty-Four Dollars and Seventy-Eight Cents (\$107,064.78) as follows:

Amending the 2021 Liquid Fuels Fund Budgets to provide for an appropriation from the unrestricted balance in the amount of One Hundred Seven Thousand Sixty-Four Dollars and Seventy-Eight Cents (\$107,064.78).

Funds are being transferred to cover the unexpected cost incurred for hiring contractors to assist with snow removal.

One Hundred Seven Thousand Sixty-Four Dollars and Seventy-Eight Cents (\$107,064.78) to be transferred from the unrestricted balance of General Fund into the Liquid Fuels Other Contract Services budgetary account (004-03-4741-0001-46)

#### Why should Council unanimously support this bill?

The removal costs for contractors were necessary to open the City for travel and Emergency services after our record snowfall.
