**WHEREAS**, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.


**WHEREAS**, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

- Description of project or scope of services to be provided:

On December 4, 2020, the City advertised a solicitation in order to secure a Contractor to furnish (lease) new motorized golf carts for use of golf patrons at the Allentown Municipal Golf Course, located at 3400 Tilghman Street, Allentown, PA. On January 4, 2021, a public opening was held for which the City received one (1) bid. After review of the bid it was decided to recommend award to the sole proposer.

- Contract Term:

The Contract term shall commence on March 1, 2021 and shall cease four (4) years thereafter. The first Lease Payment shall be paid on March 1, 2021 and shall continue for four (4) consecutive annual payments.

- List any renewal term options and duration of each renewal, if any:

Upon written notification, if necessary, this contract can be extended for up to an additional one (1) year beyond the contract expiration period.

- Maximum dollar value of all renewals provided for beyond the original term as if all renewals were exercised:

2025 option year – the cost of the cars will be \$100 less per car, per year for that fifth year. For a total renewal cost of \$59,966.00.

A vote of final approval is requested of the members of Council and by passing the accompanying resolution, this Contract will be deemed approved and awarded.
