# Experience

My experience as a firefighter throughout my fifteen years on the Allentown Fire Department includes hundreds of fire calls, EMS calls, vehicle rescues, water rescues, and fire alarms. For the first few years on the department, I was assigned as a reserve firefighter, which allowed me to move around from station to station, and gain experience from just about every officer and firefighter on the department. As a career firefighter, I would eventually work as a pipe man on E-10, driver of Truck 2, and the driver of Battalion Chief 43 before deciding to move forward and test for the Fire Marshal/Inspector test.

I would eventually test for the Fire Marshal's position in 2012 and in the 2 years that I was assigned to this position, I investigated multiple fires involving residences, autos, and brush and inspected many facilities for code compliance and permitting purposes.

As the Assistant Chief of Fire Prevention under the direction of the Deputy Fire Chief and Fire Chief, I had full management and control of all matters pertaining to the Fire Prevention Division and all subordinate Officers, Fire Marshals, Captain of Public Affairs and any member of the department assigned or detailed thereto. I was responsible for the enforcement of all Fire Prevention Laws and Ordinances related to the protection of life and property from fire, and made sure that all industrial, mercantile, institutional, educational, and high-density residential occupancies were periodically inspected.

As the Deputy Fire Chief, I am the Bureau Manager of the Fire Department and am next in line to the Fire Chief. My responsibilities include supervising and evaluating Battalion Chiefs, Assistant Chiefs, Captains and Lieutenants assigned to the respective divisions, personnel and apparatus assigned to the Fire Department so that the efficient operation of the respective divisions are accomplished, allocating the disposition of all apparatus and equipment assigned to the Fire Department and see that the equipment is kept in the best condition possible so as to be readily available for all emergencies and assisting in the preparation of the budget, especially that of the Fire Command.

### Other responsibilities include:

- acting as the Liaison Officer between the Fire Department mechanic at Constellis and the Fire Department.
- assisting in writing the Standard Requirements and Bid Specifications for new equipment, new apparatus, etc. needed for the Fire Department.
- responsible for the specialty squads assigned to the Fire Department.
- have knowledge of Federal, State and Local Statutes, Laws, Ordinances and regulations governing fire, rescue and hazardous materials
