

#### CITY OF ALLENTOWN

#### RESOLUTION

R24 - 2021

## Introduced by the Administration on February 17, 2021

Authorizes the Administration to Prepare and Submit to the Court a Declaration of Taking and Related Documentation pursuant to the Eminent Domain Code of 1964, as amended, to Acquire a Temporary Construction Easement and a Bikeway Easement Interest in the Property Located at 701 North Meadow Street, Allentown, Pennsylvania 18102 identified by the Lehigh County Assessment Office as Parcel Number 640724083828.

## Resolved by the Council of the City of Allentown, That

WHEREAS, the City of Allentown is a Home Rule City of the Third Class organized and existing under the laws of the Commonwealth of Pennsylvania and is authorized to acquire private property for an authorized public purpose under the Pennsylvania Eminent Domain Code of 1964, as amended, 26 Pa.C.S § 101, et. seq., and;

WHEREAS, the City Council has determined a 1,743 square foot temporary construction easement and a 2,644 square foot bikeway easement on the parcel located at 701 North Meadow Street in Allentown (the "Parcel") would be beneficial for the public purpose of constructing and maintaining a 10- foot wide paved multi- use path for walking and bicycling known as the Jordan Creek Greenways Trail between Turner Street and MacArthur Road that will connect Jordan Park West, Jordan Park and Jordan Meadows Park to Center City Allentown; and

**WHEREAS,** the City Council has further determined that in order to make the intended improvements, it is necessary that the Parcel be acquired through appropriate means, including, if necessary, the exercise of eminent domain.

### NOW, THEREFORE, BE IT RESOLVED that

- 1. The Solicitor or his designee is hereby authorized and directed to prepare and the Mayor is hereby authorized to pursue acquisition of the Parcel it is necessary through appropriate means, including, but not limited to, eminent domain proceedings and to execute any and all appropriate legal documents to carry out the intent of this Resolution.
- 2. The Solicitor or his designee is hereby authorized to file such a Declaration of Taking and all related documents with the Clerk of Judicial Records and the Recorder of Deeds in and for Lehigh County and to take such other steps as may be necessary to effectuate the intent of this Resolution.

# Summary and Facts of the Bill

The request is for City Council's approval for the City to acquire land for the construction of a 10-foot wide paved multi- use path for walking and bicycling known as the Jordan Creek Greenways Trail between Turner Street and MacArthur Road. The bikeway will connect Jordan Park West, Jordan Park and Jordan Meadows Park to Center City Allentown by amicable purchase or by the exercise of eminent domain, as necessary.
