AN ORDINANCE

Amending the 2021 General Fund Budget to provide for a supplemental appropriation of Twenty-Three Thousand Nine Hundred and Ten Dollars (\$23,910) from Pennsylvania Historical and Museum Commission (PHMC) to hire a professional historic preservation consultant to prepare a complete revision of the City's design guidelines for the Historic Districts.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 General Fund in the amount of Twenty-Three Thousand Nine Hundred and Ten Dollars (\$23,910) reflecting receipt of monies from PHMC to hire a professional historic preservation consultant.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

- **Summary and Facts of the Bill**

This is a request to place grant funding in the amount of \$23,910 from the Pennsylvania Historical and Museum Commission / Pennsylvania State Historic Preservation Office (PA SHPO) to hire a professional historic preservation consultant to do a complete revision of the City's Design Guidelines for Historic Districts in the 2021 budget. The grant was received in 2020 and placed in the 2020 budget. A RFQ was completed in late 2020 and was not finalized until 2021. The City received additional funds, totaling \$1,910 to support the project.

This bill allows the City to put the grant funding in the 2021 budget. The funding will be used to support the update to the City's Design Guidelines. The goal of the revision of the Design Guidelines is to create a more user-friendly document that is well illustrated, concise, in plain language, and is translated to Spanish and possibly other languages. The goals are to illustrate that historic preservation projects can be affordable, and to increase compliance with the Historic District Ordinance. The scope of work for the project includes public outreach with property owners, neighborhood groups, contractors, staff, and the HARB. This project dovetails with the recently approved Allentown Vision 2030 Comprehensive and Economic Development Plan which recognizes historic preservation as tool for economic development and for enhancing Allentown's legacy housing. In addition, the goals of making a more user-friendly Design Guidelines is in line with the Comprehensive Plan's over-arching goal of making Allentown a welcoming City and a City for all.

This grant requires a 10% cash match (\$2,391) which the City has agreed to match with funds already in the budget. Some ongoing expenses, which should be minor, include printing copies of the document as needed. Benefits will be a more user-friendly publication and ongoing better understanding of treatment of Allentown's legacy housing.
