**Resolved by the Council of the City of Allentown,**

**WHEREAS**, the City of Allentown is desirous of obtaining funds for Emergency Shelters from Pennsylvania Department of Community and Economic Development for Rapid Rehousing, Emergency Shelter and Temporary Shelter fundable under 24 CFR § 576.102 and 24 CFR § 576.104.

**NOW, THEREFORE, BE IT RESOLVED**, that shelter and homeless needs exist and have been identified in the local Consolidated Plan and the proposed grant activity addresses this need.

**BE IT FURTHER RESOLVED**, the City of Allentown will conduct the required citizen participation process.

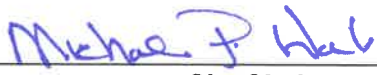
