AN ORDINANCE

Amending the 2021 General Fund Budget to provide for a supplemental appropriation of One Thousand (\$1,000) Dollars from GBU Financial Life to provide uniforms to support emergency preparedness and deployment initiatives for the Allentown Volunteer Medical Reserve Corps.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 General Fund in the amount of One Thousand (\$1,000) Dollars from a contribution from GBU Financial Life.
