## CALEA:

It was brought to my attention in November 2020 that City Council approved the Police Department to proceed with CALEA. I was unaware that the funding was appropriated in the 2020 FY since it was so late in the fiscal year.

The CALEA registration was completed December 18, 2020 and I received the invoice March 16, 2021. When I reviewed my budget, I did not see the increase in the 01-32 account for the CALEA funding. Once I looked into the location of the funding, I found out the funding was for 2020 FY and not 2021 FY. At this point the funding is no longer available to roll over into 2021.

The transferred amount requested is for the initial accreditation fee of \$ 16,125.00 plus the 2021 fee of \$ 5,500. The funds are available due to the Records Management System change over, we were able to save on our current maintenance for FileOnQ and Crime View Dashboard by only utilizing it for the first quarter of 2021.
