Welcome and Introductions

- Open Forum with Rep. Schweyer. Rep. Schweyer was on City Council when the EAC was established and wanted to be able to talk to the group about key environmental legislative topics. First mentioned is RGGI which the governor is working to implement without the support of the legislature. Without legislative action the next governor can overturn this action. The AEPS is another way to affect the energy mix in the Commonwealth and thus affect GHG emissions. Rep. Schweyer supports updating the AEPS to increase the requirement for renewables (solar, hydro and other good ideas) and that is generated here in PA. Electric Vehicles are also going to come into the market and we have PA manufacturers (Mack) that will benefit from the expansion of EV's and so we need to do work on charging stations and statewide planning. We need to plan for how EV's may affect the tax revenue that the state uses to pay for roads and bridges because these taxes are generated by a fuel tax which will decrease with more EV's being used.

EAC's can and should support legislative efforts at the state level and help local communities understand how the environmental issues can impact their lives.
