

I currently do not own or operate a business in Allentown. In 2022, it is my intention to establish a Trauma Treatment & Restorative Re-Entry program in Pennsylvania as apart of an initiative aligned with the nonprofit to provide re-entry services to formerly incarcerated persons, individuals identified as at-risk and disadvantaged, and create equality and equity in minority communities. We are piloting our first program in Georgia and South Carolina this winter.

In my current role, I serve as the founder and director of HER Village Foundation LLC, a private practice in Douglasville, Georgia that serves children, adolescents, and adults. This has given me an opportunity to understand the process of creating a business, strategic planning needs and risk assessments of underserved communities, and creating initiatives to increase client attendance and participation in sessions. I have successfully increased our caseload as a practice through creating a multi-disciplinary team and identifying and selecting contracts available to meet the needs of our community. A crucial task in my role has recently been identifying opportunities to obtain private donations for our efforts to meet counseling needs of children and adolescents in the community. I use a face-first approach, interacting directly with leaders in various roles and organizations to identify a common mission and opportunities to collaborate in meeting the need of the community.

Leadership, flexibility, strategic planning, and innovation have all been skills I have had to implement in assuming the role as Chair of the Restorative Justice Committee (RJC) and Re-entry committee of the International Association of Addictions and Offender Counselors (IAAOC). As chair, my first task was to create a strategic plan, including our goal for the fiscal year and measurable outcomes aligned with the vision of the committee and IAAOC. During my brief time in this role. I have created strategies to target graduate-level learners to increase their involvement in professional organizations and created positions in each committee that are consistent with member strengths and skills. As a part of our strategic plan, I have developed initiatives that target social justice and advocacy for offenders, ex-offenders, and persons in community supervision. Initiatives include restorative justice training/seminars, creating webinars about the role of counselors in prison reform and re-entry, budgeting to allow funding of efforts that target successfully re-entry and access to resources, and identifying presentation opportunities in criminology and lawito explore the role of counselors and other related professions in assessing and meeting the needs of persons more likely to experience incarceration. Recently, our non-Throfit achieved recognition with as a tax-exempt organization. The Restorative Justice Committee is currently creating an initiative, targeting Title 1 schools in impoverished neighborhoods. will target parents and identify programs to increase literacy, employment, financial literacy, and access to capital to breakthe cycle of poverty of their children and students while exposing? children to equitable opportunities.

As an avid believer in social justice and advocacy, diversity, service, and education, I was drawn to the Human Rights Commission of Allentown, due to the committee's combating and eradicating discrimination. It is my goal to develop programs that target discrimination against offenders and in particular, minorities but adult and juveniles that hinders successful re-entry into the community and limits their opportunity to become productive citizens of society. As a commissioner and committee member, my goal would be to conduct a risk needs assessment of vulnerable populations and pilot research on the correlation between poverty, discrimination, and mental health outcomes. With this research, I would determine the interests of other members to address employer and housing practices that encourage discrimination against this vulnerable population and aid in creating initiatives that promote equality and equity. A solid partnership with the Department of Corrections, Juvenile Justice, and Bureau of Prisons is necessary in coordinating care using a multidisciplinary and comprehensive approach to treatment and care as we strive towards reducing disparities in minority communities. It is my goal to increase funding for the committee to contribute to an array of projects that reduce discrimination and other inhumane practices. I am confident that my personal and professional experiences would enable me to excel in my role as a member and servant of the community and city of Allentown, Together, we will become the standard of excellent and a pillar of service. I would be honored to contribute my skills, experience, and passion to this initiative and the expansion of the organization. I welcome the opportunity to discuss potential contributions in an interview. Thank you for your time and consideration.
