## Introduced by the Administration on April 7, 2021

Authorizes Submission of a Formal Application to the Pennsylvania DCNR for a Grant of One Million Five Hundred Thousand Dollars (\$1,500,000) to support the Bogert's Bridge Restoration Project.

## Resolved by the Council of the City of Allentown, That

**BE IT RESOLVED**, that the City of Allentown, Lehigh County hereby requests a Park Rehabilitation and Development grant of \$1,500,000 from the Pennsylvania Department of Conservation and Natural Resources to fund rehabilitation of Bogert's Covered Bridge.

**BE IT FURTHER RESOLVED**, that the City of Allentown hereby designates Ray O'Connell, Mayor, and Seth O'Neill, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth.

**NOW, THEREFORE, BE IT RESOLVED** that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for One Million Five Hundred Thousand Dollars (\$1,500,000) in grant funds to the Pennsylvania Department of Conservation and Natural Resources.

The Parks Department is submitting an application to the Pennsylvania Department of Conservation and Natural Resources (DCNR) requesting \$1,500,000 to support the rehabilitation of Bogert's Bridge.
