Just to be clear this is not the police dept. fault, it is the fault of all of us for not demanding that the city provide a fully operational 24/7 311 center and demanding the this has the most up to date technology so the police can view a camara feed to the area they are responding to wile in rout. We, the undersigned, neighbors of Highland St. are requesting City Council to stop the installation of handicap ramps, sidewalks and improvements of front walkways to our homes. The City of Allentown has contacted all of us regarding our need to replace or build sidewalks and corner handicapped ramps and improve our front walkways. The American Disabilities Act of 1990 is the driving force behind these changes. While this was an important and valuable law to be enacted, we believe the cost of building these ramps and updated sidewalks should not fall on private homeowners but rather be the responsibility of the city since everyone in the city benefits from having these updated sidewalks and ramps. We are questioning the legality of the assessment for the costs of these improvements on to the homeowners.

According to the U.S. Access Board Technical Guide: Using the ADA Standards, "In the private sector, the ADA's coverage of housing is limited to places of public accommodation, such as social service establishments and housing provided on or behalf of a place of education. The ADA does not apply to individually owned or leased housing in the private sector not used as a public accommodation, including single family homes, condominiums or apartments.
