AN ORDINANCE

Amending the 2021 General Fund Budget to provide for a supplemental appropriation of Forty-Five Thousand Seven Hundred Fifty-Three (\$45,753.00) Dollars from the United States Department of Justice Edward Byrne Memorial JAG Grant to the City of Allentown for updating technology in seven police interview rooms.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 General Fund in the amount of Forty-Five Thousand Seven Hundred Fifty-Three (\$45,753.00) Dollars reflecting receipt of monies from the United States Department of Justice into revenue account:
