AN ORDINANCE

Amending the 2021 General Fund Budget to provide for a supplemental appropriation of Seven Thousand (\$7,000) Dollars from City Center Allentown to provide background checks and American Red Cross Lifeguard Certification Course fees for City of Allentown resident hires in the Department of Parks and Recreation.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 General Fund in the amount of Seven Thousand (\$7,000) Dollars from a contribution from City Center Allentown.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

What Department or bureau is Bill originating from? Where did the initiative for the bill originate.

This bill is originating from HR and Parks and Recreation.

Summary and Facts of the Bill

The City of Allentown will receive a donation of 7,000.00 from City Center Allentown to pay for required background check and American Red Cross Lifeguard Certification Course fees for City of Allentown Resident hires in the Parks and Recreation Department.

The City of Allentown has a goal of increasing the hiring of Allentown resident youth for seasonal positions within the Parks and Recreation Department. There is an expense of \$55.00 for background checks and \$200.00 for lifeguard certification. This required expense has resulted in a recruitment hurdle in hiring residents. City Center Allentown has agreed to donate \$7000.00 to cover these costs. This bill designates the \$7,000.00 to 34 and 50 expenditure accounts in the Parks and Recreation budget.

o What are the Benefits of doing this/Down-side of doing this

The benefits of doing this is to increase accessibility to employment for City of Allentown residents by assisting with required employment costs.

It is a key priority for the Administration to hire Allentown residents to work for the City of Allentown. It is also a priority to hire those who are from economically disadvantaged neighborhoods and diverse ethnicities, thereby representing the citizens of Allentown.

This bill allows us to meet our goal of increasing the employment of Allentown residents from economically disadvantaged neighborhoods and diverse ethnicities no cost to City of Allentown taxpayers.
