WHEREAS, it is the desire of the City of Allentown to increase the contractual sum of the previously awarded agreement with the following named contractor/consultant, for the use and purpose indicated in supporting the Recommendation of Award or Contract dated July 21, 2017:

- Description of project or scope of services to be provided and why is an increase needed:

The RFP was advertised on December 16, 2016, after review and evaluation of all proposals received, on or about April 19, 2017, City Council approved award of this contract to Michael Baker International, Inc. On July 21, 2017, the City entered into a Contract with the Vendor for consulting and engineering services for design, construction documents, cost estimates, and bidding assistance for the City of Allentown in the construction of the greenway/trail.

On April 3, 2019, a request to Amend the Contract was presented to Council and subsequently approved, in order to increase the contract value by \$114,235.00. The basis for this increase was since this project is using Federal TASA funding for construction, the project is now going through the PENNDOT Project Development and Approval Process. Meaning all plans will be developed in PENNDOT format and will be developed according to their procedures. The project limits have also been extended by approximately .6 miles for the paving of the stone trail. Additional construction plans and design effort are required to cover this area. The said First Amendment was fully executed on April 26, 2019.

On or about June 5, 2020, a Second Amendment was reviewed and fully executed in order to extend the contract term through July 20, 2022. Council approval was not necessary because it did not meet the requirements to go before Council.

A third request was submitted in order to increase the contract value by \$28,352.00, which was below 10% of the contract value and therefore Council approval was not required. The reason for the increase is a slight change in the scope of work, during the course of the project the City asked that the existing two way stop control intersections on Meadow Street between Tilghman Street and Sumner Avenue be converted to four way stop control, which required additional stop signs, stop bar pavement markings and flashing red lights to the new stop sign. The Solicitor's Officer reviewed and approved the Third Amendment, which was fully executed on December 22, 2020.

Now a Fourth Amendment is being requested because the trail has to be re-routed in order to avoid a certain parcel of land due to the inability to obtain a right- of- way acquisition from the Property owners. Additionally, the City has also requested that the trail be extended by about 400' to Green Street and to use 300' of Green Street with shared roadway and improved sidewalk configuration in order to avoid the said parcel at issue. This alteration will cause an increase in cost by \$46,598.00. It is now before Council for review and approval.
