***Resolved by the Council of the City of Allentown, That***

**BE IT RESOLVED**, that the City of Allentown, Lehigh County hereby requests a Redevelopment Assistance Capital Program grant of \$1,00,000 from the Pennsylvania Office of the Budget to fund expansion of the Lehigh County Humane Society.

**BE IT FURTHER RESOLVED**, that the City of Allentown hereby designates Ray O'Connell, Mayor, and Seth O'Neill, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth.

**NOW, THEREFORE, BE IT RESOLVED** that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for One Million Dollars (\$1,000,000) in Redevelopment Assistance Capital Program funds to the Commonwealth of Pennsylvania Office of the Budget.

The Lehigh County Humane Society, the Subgrantee, is submitting a formal application to the State Office of the Budget, for which the City will serve as the Grantee. The \$1,000,000 awarded in Redevelopment Assistance Capital Program (RACP) funds will support the LCHS Expansion Project.
