Authorizes Submission of a Formal Application to the Pennsylvania Office of the Budget for a Grant of Seven Hundred Fifty Thousand Dollars (\$750,000) to support the Bogert's Bridge Restoration Project.

Resolved by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a Redevelopment Assistance Capital Program grant of \$750,000 from the Pennsylvania Office of the Budget to fund rehabilitation of Bogert's Covered Bridge.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Ray O'Connell, Mayor, and Seth O'Neill, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for Seven Hundred Fifty Thousand Dollars (\$750,000) in Redevelopment Assistance Capital Program funds to the Commonwealth of Pennsylvania Office of the Budget.

The grant request is for \$750,000. Funds must be matched dollar for dollar. The City has committed \$375,000 in Capital Project funding, has an additional \$110,000 committed from prior grants received and private funding sources, and is applying for a \$1.5 million grant from the Department of Conservation and Natural Resources (DCNR) to help fund the remainder of the \$3.2 million rehab project.
