AN ORDINANCE

Amending the 2021 Grant Fund Budget to provide for a supplemental appropriation of Eight Million (\$8,000,000) Dollar for a Pennsylvania Redevelopment Assistance Capital Project pass through grant for the Riverfront Revitalization Project.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 Grant Fund in the amount of Eight Million (\$8,000,000) Dollars in the following manner:

Purpose of the ordinance is to appropriate the revenue and expenses for Phases II through IV of the Redevelopment Assistance Capital Project (RACP) grant for the Riverfront Revitalization Project (the Waterfront Development and Neiveiller Brewery). In total, \$10 million in RACP funding was awarded to this project, of which the City is the grantee. When the Grant Fund was established, \$2 million was initially appropriated to account for Phase I of the grant.
