Old Business

2021 Goals Reports

- Waste Minimization/Food Waste (Tinku): A job description was developed for an internship and shared with members. Should it be more focused scope so that the study is smaller and work can start sooner? Food reclamation pilot program with Giant and intown food pantries. We will redo the scope to limit the job description and Holly will investigate funding for a full food waste study. Members agree to change the scope.
- 2. Micro-mobility (Jennifer): Intern is working on it and will submit a report in the coming weeks.
- 3. Climate Action Inventory and CDP Questionnaire (Tinku) Tinku reviewed the inventory items and classifications at this meeting. Tinku sent both documents to the city and a meeting has been scheduled with city staff on both documents in June.
- 4. Greenhouse Gas Inventory (Tinku) Tinku noted that the full report is still being finalized and should be posted along with the PowerPoint of the inventory. We need assistance in further publicizing these documents.
- 5. Park Spark Project (Jennifer) This is currently on hold.. It will continue after an on-site location at Lehigh University has been selected.
- 6. EAC Earth Day Event (Holly) We had about 23 people attend. We created a volunteer listing that included internship. Send listing to sororities/ fraternities. Holly and Lacey will work together to share info with students for fall- maybe an on-campus event.
- 7. Rain Gardens (Muhlenberg -- Sadie)- no update for now.
- 8. Create a public repository of sustainability data (Tinku and city)- no update
- 9. Build social media following launch and use IG (Jon/ Sadie)- Jon will lead this effort.
- 10. Sustainable Pennsylvania Communities Certification (Tinku)- pending city finalization
- 11. Sustainable Business Survey and Recognition Program on hold (Tinku)
- 12. Get more Council input on EAC activities (Dave/TInku) Tinku asked Josh to be more supportive and provide a platform for our virtual meetings. Ann will ask the IT dept. Dave will talk to Josh about joining EAC meetings more regularly.
