AN ORDINANCE

An Ordinance of the City of Allentown, County of Lehigh and Commonwealth of Pennsylvania, revising Article 400 Department of Parks and Recreation Fees to add Section 400.09 Credit Card Convenience Fee.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the Fees portion of Article 400, Allentown Codified Ordinances, be amended as follows:

400.09 CREDIT CARD CONVENIENCE FEE

Whenever a credit card is used by a consumer to pay for Parks and Recreation Department offerings (i.e. concessions / daily admissions / memberships / facility rental fees / registrations) a convenience fee of Three (3%) Percent of the total due will be added to the transaction to offset the costs of facilitating the credit card transaction.

SECTION TWO: That all Ordinances or parts of Ordinances conflicting with the provisions of this Ordinance be and the same are hereby repealed.

SECTION THREE: That this Ordinance takes effect ten (10) days after final passage.

This bill creates a convenience fee of 3% for credit card transactions which impacts the Parks and Recreation Department under Article 400 – Department of Parks and Recreation Fees

The goal of this bill is to increase the convenience for the consumer to pay for Parks and Recreation Department offerings (concessions / daily admissions / memberships / facility rental fees / registrations)

The benefit of this bill is that an increase of convenience for the consumer to purchase items will lead to an increase in revenue.
