AN ORDINANCE

Amending the 2021 General Fund Budget to provide for a supplemental appropriation of Seven Hundred Fifty (\$750) Dollars. Two Hundred Fifty (\$250) Dollars from the Lehigh County Medical Society and Five Hundred (\$500) Dollars from the Greater Lehigh Valley Independent Physician Association to provide supplies for those volunteering to work the COVID vaccination clinic.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 General Fund in the amount of Seven Hundred Fifty (\$750) Dollars from a contribution from the Lehigh County Medical Society and one from the Lehigh Valley Independent Physician Association.
