#### Authorizes submission of the HUD Eviction Prevention Grant Application

Resolved by the Council of the City of Allentown, That

**WHEREAS** the City of Allentown is desirous of obtaining funds from Housing and Urban Development (HUD) for legal aid, eviction prevention, eviction mediation, and rental assistance under 24 CFR § 982.310.

**NOW, THEREFORE, BE IT RESOLVED**, that eviction prevention and mediation needs exist and have been identified in the local Consolidated Plan and the proposed grant activity addresses this need.

**BE IT FURTHER RESOLVED;** the City of Allentown will conduct the required citizen participation process.

**BE IT FURTHER RESOLVED,** the City of Allentown Department of Community and Economic Development (DCED) will assure the provision of other necessary funds to make the activity feasible.

**BE IT FURTHER RESOLVED**, that DCED will reimburse the commonwealth for any expenditures found by DCED to be ineligible.

**BE IT FURTHER RESOLVED** that the appropriate officer of the City of Allentown is directed to execute a certificate attesting to the adoption of this Resolution and to furnish a copy of this Resolution to Department of Community and Economic Development (DCED).
