## AN ORDINANCE

Amending the 2021 General Fund by funding the Public Safety Analyst position currently budgeted for One (\$1) Dollar in the Police Department budget.

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That page 115 of the General Fund budget be amended by funding the Public Safety Analyst (12N) currently budgeted at One (\$1) Dollar to be funded at an annual salary of Sixty-Four Thousand Six Hundred Ninety-Seven (\$64,697) Dollars.

SECTION TWO: That City Council authorizes the transfer in the amount of Twenty-Seven Thousand Three Hundred Seventy-Two (\$27,372) Dollars to fund the remaining eleven (11) pay periods of 2021 in the following manner:
