Authorization for and additional \$250,990 for the contract with Construction Masters Services, LLC to add additional ADA Ramp locations as a result of a lower bid, expending remaining CDBG funds, the contract term shall expire on April 1, 2022.

WHEREAS, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to increase the contractual sum of the previously awarded agreement with the following named contractor/consultant, for the use and purpose indicated in supporting the Recommendation of Award or Contract dated June 22, 2021:

- 1. Name of Contractor/Consultant: Construction Masters Services, LLC
- 2. Project or Contract Reference: C12-000294- BID No. 2021-09-2021 CDBG ADA PEDESTRIAN RAMP PROGRAM (VARIOUS LOCATIONS)
- 3. Description of Service(s) to be provided: To secure a Contractor to construct/reconstruct ADA Ramps in accordance with the Americans with Disability Act, and remove and dispose of sidewalk and/or concrete curb, located within the City limits, along with incidental work as may be authorized and required by the Contract Manager

Pursuant to City Ordinances, Article 130.16, this Recommendation of Award is before City Council for its approval of the contract consideration increase.

 This recommendation is for a contract consideration increase of 10% or more for an existing contractual sum. Said contract was previously bid and awarded under city policies.

Description of project or scope of services to be provided and why is an increase needed:

On April 27, 2021, the City advertised a solicitation on Public Purchase in order to obtain the services of a Contractor to construct/reconstruct ADA Ramps in accordance with the Americans with Disability Act and remove and dispose of sidewalk and/or concrete curb, located within the City limits, along with incidental work as may be authorized and required by the Contract Administrator. On May 25, 2021, the public opening was held for which four (4) proposals were received by electronic submission. All proposals were reviewed, and it was determined that the recommendation of award would go to the lowest, responsive, responsible bidder, Construction Masters Services, LLC. On June 2, 2021, City

Council approved the award of the contract to Construction Masters and on June 22, 2021, the contract was fully executed.

At the time of time of solicitation of this project the City had a specific sum of monies in CDBG funds that needed to be used. The bid came in under the budgeted sum for which needed to be expended. Therefore, at this time the City would like to amend its current contract with the Contractor in order to add additional Ada Ramp locations throughout the City, in order to expend the remaining CDBG funds.

The current contract term shall expire on April 1, 2022.

Upon written notification, this contract can be extended for up to an additional three (3) months beyond the contract expiration period.
