It is with great enthusiasm that I am nominating Charles Roca to become the city's Chief of Police.

Roca was sworn in as an Allentown Police Officer on January 22, 2002.

After his training period, Roca's first assignment was as a vice detective where he conducted numerous investigations into the illicit drug market as well as street level prostitution. He interacted with numerous law enforcement agencies as well as the District Attorney's office.

He returned to patrol in 2011 and was assigned as a patrolman/K-9 handler. This work emphasized the importance of working as a team and further interacting with the community. He was promoted to Sergeant where he served in the 4<sup>th</sup> Platoon, 2<sup>nd</sup> Platoon and the Vice Unit. In April 2016 Assistant Chief Roca was promoted to Lieutenant and given command of 1<sup>st</sup> Platoon. In April 2018 he was promoted to Captain. In 2019 he became Assistant Chief.

Roca holds a B. A. from King's College located in Wilkes-Barre, PA. He majored in criminal justice. He is fluent in Spanish. Assistant Chief Roca obtained a DEA license to procure drugs for the purpose of K-9 scent training to enhance the K-9's abilities, maintained and enhanced K-9 records for training and usages to advise Police Administration. He has developed positive relations with the Hispanic/Latino community through day-to-day interactions.

His salary will be \$130,000. I am honored to forward his name to you for confirmation.
