Authorization for Contract with <u>G&B Construction Group, Inc.</u> in the amount of <u>\$573,170</u> to remove and dispose of sidewalk and/or concrete curb, construct/reconstruct curb and sidewalk, in conjunction with the 2021 streets improvements program, competitively bid, 2 bids.

WHEREAS, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

- 1. Name of Contractor/Consultant: G&B Construction Group, Inc.
- 2. Project or Contract Reference: C12-000319 Bid No. 2021-21
- 3. Description of Service(s): To obtain a Contractor to remove and dispose of sidewalk and/or concrete curb, construct/reconstruct curb and sidewalk, in conjunction with the 2021 streets improvements program located within the City limits, along with incidental work as may be authorized and required by the City Engineer.

Description of project or scope of services to be provided:

On July 16, 2021, the City advertised a solicitation in order to obtain a Contractor to remove and dispose of sidewalk and/or concrete curb, construct/reconstruct curb and sidewalk, in conjunction with the 2021 streets improvements program located within the City limits, along with incidental work as may be authorized and required by the City Engineer. A Public Opening was held on August 13, 2021, for which two (2) bid submissions were received. Upon review of both submissions, it was determined that G&B Construction was the lowest, responsive, responsible bidder.

Contract Term:

The contract term shall commence upon the issuance of the Notice to Proceed. The work shall begin within ten (10) days thereafter and shall be completed within six (6) months.

List any renewal term options and duration of each renewal, if any:

Upon written notification, this contract can be extended for up to an additional three (3) months beyond the contract expiration period.

 Maximum dollar value of all renewals provided for beyond the original term as if all renewals were exercised:

If requested in writing ninety (90) days prior to the end of the first contract term, or any subsequent renewal terms, the City may consider pricing increases if the following conditions exist:

- 1. There is a verifiable price increase to the Contractor.
- 2. The Contractor submits, in writing, notification of the price increase.
- 3. The price increase shall be comparable to documented manufacturers' or distributors prices' price changes or industry related indices.
- 4. Price increases due to seasonal and/or unforeseen market conditions; and
- 5. The Contractor shall submit the above information to the Purchasing Department no less than ninety (90) days prior to the effective date of the requested price increase.

A vote of final approval is requested of the members of Council and by passing the accompanying resolution, this Contract will be deemed approved and awarded.
