**BE IT FURTHER RESOLVED**, that the City of Allentown hereby designates Ray O'Connell, Mayor, and Seth O'Neill, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth.

**NOW, THEREFORE, BE IT RESOLVED** that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for TEN THOUSAND DOLLARS (\$10,000.00) in Keystone Communities grant funds to the Pennsylvania Department of Community & Economic Development.
