He talked about the 8th and 10th Wards. He asked for a city walk to display what is happening to the 8th and 10th Wards.

Mr. Daryl Hendricks asked Mr. Heffentrager about the Jordan Heights Neighborhood. He stated that it was a neighborhood walk yesterday.

Mr. Kenneth Heffentrager stated that some of the worst blighted properties are in the 10th Ward section of Jordan Heights.

Mr. Julio Guridy stated that he is listening to Mr. Heffentrager and he wants support. I would request as a member of the Community and Economic Development Committee that Dr. McGuire and the committee to coordinate with Mr. Heffentrager and have a walk and check out the places that he is recommending that we go to see.

Mr. Brent Hartzell asked the intersection to ensure he has it down proper.

### **Communications: Watson Skinner Memorial Award: Doug Snyder**

Mr. Ray O'Connell stated that tonight is a great night for Allentown City Council. Tonight, we give out our Annual Watson Skinner Award. Watson Skinner served on Council between 1974 - 1990, including terms as president. He became the Mayor's assistant for Economic Development which paved the way for the creation of the Allentown Economic Development Corporation. He was the first person to hold the position of executive vice president of the Allentown Economic Development Corporation. He hosted a weekly radio program and local cable television programs, Community Spotlight and Ideas Under Fire. He served as Chairman of many community organizations, including the Rotary, CADA, and the Allentown Reinvestment Committee. Watson proudly served on the board of St. Luke's Hospital. After moving on from City Council, Watson love of Allentown never diminished and remained ever involved in community development and volunteerism until his untimely death in 2012. "I have a very strong love affair with Allentown and its citizens. I don't try to

explain it, it's there". Watson Skinner shared in his speech in November of 1987.

This award will be awarded annually to a member of the Allentown community that represents the dedication to continuous community improvement over a significant period of one's lifetime, as Watson Skinner dedicated his life & work to the City of Allentown and its citizens. The award recipient will be chosen from a list of nominees compiled from input from city and community leaders and Watson's family. The annual award will be presented at an Allentown City Council Meeting in the spring of each year.

A nominee must have demonstrated significant and outstanding commitment to improving the quality of life in the Allentown community. Nominees should have demonstrated persistence in the face of adversity in attempting to meet community goals. Special consideration will be given to nominees that have served in multiple volunteer capacities. A nominee may have served the community with distinction in her/his professional capacity, in addition to one's volunteer service.

At this time, I want to talk a little bit about the recipient. I have known the recipient for many, many years. The recipient is a fine gentleman that went to South Mountain Junior High, and Watson Skinner was his guidance Counselor. After leaving South Mountain Junior High, went on the Allen High and had an extremely successful career as a basketball player. Earned a scholarship to Princeton University. When on to Princeton University and played for Pete Correal, from there he stayed in the Princeton area and coached basketball at Princeton High School for many years. He came to Allentown School District as a teacher at Allen High School and has been the basketball coach for Allen High School ever since. Without further a due, I would like to introduce a gentleman who knows the Award Recipient extremely well, who has some remarks about the award recipient.

Mr. Mike Kamenski thanked City Council for granting the honor and the enormous task to help present the Watson Skinner Award. Councilman Skinner was a very well-respected and dedicated teacher, community leader and advocate for our city. I can't think of no person that would exemplify these qualities of this award, Mr. Doug Snyder. Coach Snyder made the choice back in 1997 to apply for the boys basketball head coaching job at William Allen after a successful coaching career at Princeton High School in New Jersey. Wanting to give back to his alma mater in the city he was born and raised in, and took over the reigns of the program from another outstanding teacher, coach and gentleman Mr. John Donmoyer, Coach Snyder has successfully continued to build on the

foundation established by John Donmoyer, Jay Miles and J Birney Crum in numerous ways. Even though Coach Snyder is more known as a basketball coach in the community, first and foremost he considers himself as a social studies teacher. Students that I have met and had him in class at William Allen Speaks highly of his teaching and how his history and economic classes are. I know from the years that I coached under him I loved discussing topics like the president's politics and other topics of history and made me wish I had him as a student. Many of his former players are helping out as teachers, mentors, school principals, business owners, executives, community leaders and parents. With many of jobs and roles in society. Some of those players have come here tonight to witness Coach Snyder receive this honor. In fact, I could think of no better quote to describes Coach Snyder then the quote used by his long-time and Assistant Coach and high school classmate, Mark Smith. "You will never find a high school coach in this area and beyond that will out work Doug Snyder". It was personally an honor and a privilege to learn about that Doug Snyder work ethic for seven years as part of his staff at William Allen. Coach Snyder is even a better person than he is a basketball coach. Every student, player and colleague is better in someway for having to spend some time around him and I can think of no better person to receive this honor. Coach congratulations on receiving the Watson Skinner Memorial Award and thank you for all that you have done to give back to the City of Allentown.

Mr. Doug Snyder stated that he is overwhelmed and thanked you Mr. President, and everybody here for this honor. I really appreciate it and the kind words from Mike and the family involvement. When Ray approached me a little while ago and we had a discussion and I gave you information, Watson Skinner was my Guidance Counselor at South Mountain. The things that I remember from him are certain dignity, certain professionalism and he was the most articulate teacher using vocabulary words that I ever approached or encountered in my career in the Allentown School District. That always stayed with me that the fact that man loved words and loved speech and loved language and it rubbed off on me and hopefully I am partially as articulate as he is in his use of the English language. That was as a Junior High School Guidance Counselor. I always felt that he was probably well above his position in helping kids. It makes it very easy when you have young men and colleagues like the ones sitting back there. Bob Freed, sitting back in the corner was my teammate at Allen High School, my classmate at Allen High School, and for almost 20 years my Assistant Coach. Mike Kamenski who shared those words was my Assistant Coach for many years. It makes it very easy. When you have guys like this and these young men, we have Will Sang, Johnny Aswata, Dan Freed, Mark Stewart, Debbie Stewart and Paul Davis. I am proud to be a Native Allentonian, born and raised in South Allentown Wyoming

Street. I walked to Jefferson, went to South Mountain Junior High and went to Allen High School. Playground instructor the in Allentown Park System for five years. I am 20 years into my teaching and coaching career at Allen High School. It is important for my to give back to this city. I just really appreciate your award and your kind words. Thank you very much.

Mr. Ray O'Connell thanked the Skinner Family. He congratulated Doug Snyder and said it was well deserved.

Mr. Ray O'Connell thanked Mr. Kamenski. At this time, I would like to invite the Skinner Family up. He stated that he saw Michael Skinner, son Patrick, and daughter Patton, David, and Patricia.

Mr. Patrick Skinner thanked Doug Snyder for everything he has done.

### City Controller's Report

Mr. Jeff Glazier stated that they finished the Dental Benefits Audit and when the department finishes an audit, it goes out to Council and gets posted on the website. Unfortunately, the way the website is currently setup if you want a copy of a contract or an audit, you have to email and ask for it. We are certainly working with IT to bring our website from the 1990s into the 21st Century. We have a very small staff, but a dedicated staff in the Controller's office. We have a very good auditor in Jacqui Moore, and some excellent administrative support in Shery Baublitz. The quality they put in is certainly reflective in the quality of the audit. The dental benefits that are administered by HR and they were exceptionally cooperative as have all the departments have been when the Controller's office performs an audit. The spirit is whatever we find, if there is an issue we want to rectify and go forward. They looked at if the city's dental benefits were in compliance with payroll deductions to determine whether employees and benefit deductions are enrolled in the proper plan to determine if the providers enrollment listing is consistent with the Human Resource records. The period we audited was April 2016. The major finding and this will be true not only with dental, but medical and probably vision and SEIU 32 BJ is that you can't verify the claims. The bills just has gross amounts on them. They don't list individual claims information. Part of it is HIPAA information.
