Mayor Pawlowski stated Section 805 - Section B states that after a Public Hearing the City Council may adopt the budget with or without Amendments. He stated that since Council is increasing an expenditures, they have to outline where the revenue is coming from.

Mr. Ray O'Connell stated from the General Fund. Our amendment is 1.5 plus 1.5 for 3 percent. Any comments from my colleagues or the public.

Mr. Ray O'Connell stated that they did a Motion and a second.

2. Acceptance of Budget memos presented by the Mayor with the exception of provisions in conflict with City Council's budget amendments.

He asked any comments from his colleagues or the public.

Mr. Alan Jennings, 2130 Gordon Street, stated that this is on the elimination of certain positions that were funded at a \$1. He considers each of them as friends and he considered the Mayor to be a friend. He stated that this is not working. We lost two extremely qualified people in the Department and Community and Economic Development. Morale in this building is a disaster. He asked for it to stop. We can't make this city better under the certain circumstances.

Mr. Ray O'Connell stated to Mr. Jennings that he couldn't agree with him more. Those positions are in the budget for \$1. There is nothing to say if the Mayor brings a viable candidate who is qualified to do any of those positions.

Mr. Daryl Hendricks stated that he truly appreciates the comments Mr. Jennings has made. I think those comments should have been made to the person more responsible then anybody here. That person is the Mayor of the City of Allentown.

Ms. Candida Affa stated that she completely agrees with Mr. Jennings. It is the citizens, Allentown, when the directors and the chiefs of police say they are concerned, I'm concerned. It is not about Ed Pawlowski. It is about the Budget. She stated that she reached out to the Mayor.

Mr. Julio Guridy stated that he appreciates what Mr. Jennings said. It comes a time when we have to do something to provide more confidence to the public.

Mr. Ray O'Connell asked any other comments from my colleagues.

Mayor Pawlowski stated that people are leaving because they are retiring. He asked Ms. Wild in Section 308 and Section 209 of the Charter, it talks about who has the ability to hire and maintain staff. He stated that it is in direct violation of the Charter.

Mr. Ray O'Connell stated that he never said choose. If you would bring a viable candidate that would have the integrity, the honesty, and the qualifications we would be more than willing to listen to you and the candidate.

Mayor Pawlowski stated that he did bring a viable candidate. His name is Oscar Montoya. He has three Master's Degrees and would be the first Latino candidate to serve in the position of Managing Director.

Mr. Michael Molovinsky, 3530 Congress Street, stated that before Mr. Pawlowski's first term that began in 2006 there never was a Managing Director. After you did not approve the funding, he tried to make Mr. Walker the Managing Director. There are plenty of supervisors that can carry the work of the city.

Ms. Susan Wild stated that she is not going to comment and this point if it is because she is not clear on what the proposal is.

Mayor Pawlowski stated that he did not arbitrarily hire a Managing Director. You all approved a salary increase for the Managing Director in 2015. By the way, there was a position before that. It was called Chief of Staff.

Mr. Ray O'Connell agreed with Mayor Pawlowski.

Mr. Ray O'Connell asked any comments from my colleagues or the public.

Mayor Pawlowski stated that if you go along with your proposed cuts, the 10 percent for contractual services, I need to understand how I am suppose to administer 433,000 contract that you approved with an allocation of \$390,000.

Mr. Roger MacLean asked if it was for Crossing Guards and say don't we get \$150,000 from the school district.

Mayor Pawlowski stated that we do, but it is already built into the contract. You are reduced the total expenditure. He asked Ms. Wild to say what the city can expect by relaying to vendors when they are no longer want to get paid under the signed contract.

Ms. Susan Wild stated that is too general of a question for me to be able to answer. For the Crossing Guard contract, the contract amount is what we agreed upon with the vendor. The amount we received from the school district goes towards that.

Mr. Julio Guridy stated that for all budget transfers some of the contractual obligations, you could still bring them in and we can do a budget transfer.

Mayor Pawlowski asked why do the cut to begin with. What is the point of the cut.

Mr. Ray O'Connell asked any other comments from the public.

Ms. Candida Affa stated that has always been my question. The fact that we are going to cut these and get budget transfers.

Mr. Ray O'Connell stated that we are reducing Account 46.

Mr. Julio Guridy stated that Account 46 is an account that has many things in them. Some are contractual and some are not. The money is there, in that account.

Mayor Pawlowski stated that the budget requires us to be balanced. The budget is not balanced in accordance to the Charter. Our fleet management contract is \$2 million. Can you please explain to me which vehicles you do not want me to service.

Mr. Ray O'Connell stated service as many as you can for \$1.8 million.

Mr. Julio Guridy stated that it is the same process.

Mr. Jeff Glazier stated that it seems to me that the amendment to reduce the Account 46 by 10 percent, reduces the whole allocations at 10 percent. The Mayor has raised some fair points, there are expenses there that impact the safety and operations of the city. To say that you are cutting contracts by 10 percent is not accurate. You are cutting the line item.

Mayor Pawlowski stated that we gave you a balanced budget that was aster. There were no fluff in the line item or in this budget.

Mr. Ray O'Connell stated that they went through that. We went over the impact.

Mr. Julio Guridy asked that this is our job and your job is to present a

balanced budget. Our job is to look at the budget and study it and change it

Ms. Candida Affa stated that she disagrees that this tax is a better tax than the property tax. One way of another, we are going to have to pay a tax. We have a workforce out there that is flat.

Mr. Julio Guridy stated that he agrees with Ms. Affa that it is a fairer tax. He is not one that likes to increase property taxes.

Mr. Ray O'Connell asked any other comments on the EIT tax rate.

Mayor Pawlowski stated that he doesn't see how it will save somebody from being homeless. We are talking about a \$16 amount here for the average ratepayer.

Mr. Brent Hartzell thanked Mr. O'Connell and stated that when the announcement came last week that \$610,000 was being reduced from the EIT. I did not get clarity on what the new rate is going to be. I would presume that you will be doing a rate other than two percent.

Mr. Ray O'Connell stated that the 10 percent reduction in the EIT was the 10 percent of the increase.

Mayor Pawlowski asked what will be the new rate.

Mr. Brent Hartzell stated that \$600,000 decrease this year would come from the new tax. To get that much of a decline in revenue is going to come from revenue. The annualized affect will be \$800,000.

Mayor Pawlowski stated that we would have to report that rate to DCED so they can publicize it to employers.

Mr. Ray O'Connell stated that you said the increase was .35. Take 10

percent off of that. It will be 1.965 percent.

Mr. Brent Hartzell stated that at that point you are talking 1.965 if you are intending to take away 10 percent.

Mr. Ray O'Connell asked any other comments from the public.

Ms. Susan Wild stated that you have to have a rate.

Mayor Pawlowski stated that he would suggest to get to the \$600,000 based on Mr. Hartzell's said, you should not do 1.965. You should be higher.

Mr. Julio Guridy stated that we make it 1.975.

Mr. Brent Hartzell stated that the impact in going to 1.975 as opposed to two percent will be a \$425,000 impact in this year. That will be a 3/4 impact.
