Ms. Beth Ann Strohl stated that this is Change Order #4 to this Contract as Mr. Hanlon indicated. It is slightly over \$185,000. This was presented to the Change Order Committee in March and it was approved by the Change Order Committee. It was on the March 15th Agenda, but due to the

weather it was put in front of you now. Ms. Taylor is here to answer any questions you have regarding the specifics of the Change Order.

Mr. Ray O'Connell asked if any comments from my colleagues about Cedar Beach Pool and another Changer Order.

Mr. Julio Guridy stated that he knows that this will be the last high Change Order that we would make. He stated that he is very concerned that we keep putting money in this project. It seems like a bottomless pit that we keep throwing money in there. He is hoping that what is explained to Council in the report sticks and we don't have to spend any more high amount of Change Orders as we had in the past. I would love to see the pool open this summer.

Ms. Cynthia Mota stated that she feels the same way. She doesn't think that this will be the last change order. I know that it is going to be open and everybody is working hard. Let's be realistic. We are hoping for the best.

Mr. Ray O'Connell stated that this has been screwed up from the very beginning. No fault of right out there. This pool is going to come out to about \$3.1 million - \$3.2 million. We are between a rock and a hard place. Frank has given us good advice. We can't stop. It is a total embarrassment to the City of Allentown that we are paying \$3.2 million for a swimming pool.

Mr. Daryl Hendricks stated that thank God we are closer to the end, then the beginning. The word of the day is accountability and we need to stay with that.

Mr. Ray O'Connell asked if there are any other comments from my colleagues or the public.

Mr. Lou Hershman asked much did we budget for Cedar Beach. Did you approve anymore Transfers? Did you approve the Transfer of funds from one pool to Cedar Beach pool?

Mr. Ray O'Connell stated \$1.8 million. The last Change Order we approved for \$681,000. This is another \$188,000 on top of it.

Mr. Brent Hartzell stated that this is a General Fund set aside for Capital. In recent years it was intended for several pools.

Ms. Helen Hahn, 2016 E. Highland Street, stated as a little girl, she had to older sisters that took her on a trolley and a bus to get to Cedar Beach. We lived in RD60 Farmington. Farmington is now Salisbury Township

which now has Allentown addresses. We went to Cedar Beach and it was a sandy-bottom pool. Where did that water come from?

Mr. Julio Guridy stated probably from the Creek.

Mr. Ray O'Connell stated that you will see under Communications. We had an Executive Session with the Solicitor and we will move forward.

Ms. Cynthia Mota stated that it was a mistake. She stated that hopefully the nightmare will be almost over.

Mr. Julio Guridy stated that we are so far ahead now and we invested so much money into it. It is really the smart thing to do and the proper thing to do is to complete it.

Mr. Ray O'Connell stated that it will be over when we get the final bill.

Ms. Candida Affa stated that there are so many restrictions now. We need filters, chlorine, and so many things. We can't have a water hole. There are rules and regulations and this is what costs a lot of money.

Ms. Beth Ann Strohl stated that in late summer, early fall 2016 the city released an RFP for various financial services that included general banking, purchasing card services and credit card processing services and investment services. The next two Resolutions that you see in front of you are awards based on the evaluations conducted. This resolution is for an award to TD Bank for the city's general banking and purchasing card services.

Mr. Ray O'Connell asked how much money. How does it work.

Ms. Beth Ann Strohl stated that there are no transaction cost to the city.

Mr. Julio Guridy stated that in addition to the issue of credit cards to some

of the city's departments, you will issue a card to them as well.

Ms. Beth Ann Strohl stated that within the credit cards there are options to place restrictions which makes them a key card. The end line users will have certain restrictions on those cards. The hope is to reduce our transaction cost for dollar value purchases. There will be a max limit for the card.

Mr. Ray O'Connell asked if there are any other comments from Council or the public.

Ms. Beth Ann Strohl stated that this stems from the same RFP for financial services. It was broken down in four components. Investment Services was one of those components. The city reviewed multiple proposals with the evaluations committee.

Mr. Ray O'Connell asked if there are any comments from my colleagues or the public.

Dr. David McGuire asked what is the outstanding feature they proposed.

Mr. Brent Hartzell stated that going back over a year we brought over a consultant to assist the city with how our pooled and nonpooled cash was being invested as it has been talked about. The interest rates on bank accounts are virtually zero. In the RFP the city looked at entities that had experience on the investment of short-term cash.

Mr. Ray O'Connell asked if there are any other comments on R62.

Mr. Glenn Hunsicker asked if there was more information on this proposal. This says authorization for award of a contract.

Mr. Brent Hartzell stated that he figured that when this came up it would be an issue. It is not a certainty that investments will be made. We have to make a minimum commitment if we go with them of \$5 million and there will be some fees attached to that. If the environment is right for this we will go ahead and do the investments with the expectation that we are looking at a 100 basis point return.

Mr. Glenn Hunsicker stated that there is a risk to this.

Mr. Brent Hartzell stated that at this time there has been no anticipated return on cash investments put in the budget. We have gone through the process with consultants and this was an intention to go forward. If we were to invest \$5 million over the course of a year our anticipation is that we would get close to \$50,000 more in cash then what we are

doing right now.

Mr. Glenn Hunsicker stated that we are coming off of very low interest rates. We have to have projections of interest rates. For them to make this prediction it is probably fairly safe. He stated that it sounds good, but he has reservations on what they are doing.

Mr. Lou Hershman asked when will the Investment Advisory Committee meet. On that committee, it supposed to have a professional investor.

Mr. Julio Guridy stated that he believes *Mr.* Hartzell stated that it would be 35 basis points that we are liable to get 55 basis point return.

Mr. Brent Hartzell stated that the intention is to actually net at a 100. The returns that we are seeing that have been presented to us is upward of 100 basis points. We anticipating a one percent net return on the investment. There is never a guarantee.

Mr. Glenn Hunsicker stated that if you plan on taking the \$5 million out of the stabilization then you have to cancel or redo that Ordinance and make it a loan.

Mr. Lou Hershman stated that Pennsylvania has a law that we can invest short-term and long-term. He stated that he doesn't think that they need an Investment Manager to tell us what short-term investment we can put in or long-term investment we can put in. He suggested that a committee be formed.

Mr. Ray O'Connell asked if there are any other comments.

Mr. Tom Hahn, 2016 E. Highland Street, stated that he still has not gotten a report on the original intent of the Stabilization Fund and the interest that was on the lockbox money that supposed to have been three and a half percent to pay down the loan.

Mr. Ray O'Connell stated that is irrelevant to R62.

Mr. Roger MacLean stated that we have money in Wells Fargo Bank that we pay bills out of that we hold and save. Instead of having money in Wells Fargo Bank or any bank and getting that pittance there we can move it into here and get a little bit more.

Mr. Brent Hartzell stated that your understanding is correct.

Mr. Ray O'Connell asked if there are any other comments from Council or the public.

Mr. Glen Keller, 2726 Fernor Street, asked what funds these are, as far as not just stabilization funds or pension obligation funds or accounts or any other cash balance accounts. If they are cash balance accounts that are considered reserves for the budget of the City of Allentown. How does this investment plan integrate with the guidance to maintain three percent of the total amount of the general funds account in reserves.

Mr. Brent Hartzell stated that any basis of funds within our cash pooled, non-pooled or whatever the source, if there is a specific designation legally. It has to be applied to it that would not make the funds available we are not going to touch them.

Mr. Ray O'Connell asked if anyone else from the public.
