Ms. Beth Ann Strohl stated that this is the second Change Order against this contract. This was approved by the Change Order Committee on July 18. It exceeded the cost of the 10 percent threshold that is why you are seeing this Change Order.

Mr. Roger MacLean stated that when he sees Change Orders all the time he thinks about the pool. What happened here that we have this cost overrun that we have to have a Change Order?

Mr. Ted Berger stated that this Change Order is a very small one for \$5,000. There were a couple things that happened on the project with the design phase. There were a couple of street lights that the new Sacred Heart development on 5th and Turner wanted to put in a couple more street lights then we expected. We have to put additional lights on. Part of the project that we do the lights and they do the concrete bases. Another small order of the Change Order is originally we had a connection on the PPL Pole that in the meantime PPL decided to remove. It is a small amount to complete the project.

Ms. Candida Affa asked about the lights.

Mr. Ted Berger stated that they are the new LED Pedestrian Lights. It is pedestrian lights from Turner Street to 4th to 7th Streets. The new LED pedestrian lights.

Mr. Daryl Hendricks asked if these were unanticipated lights. We did not realize that the project was going to include these bases that needed a pole to complete them.

Mr. Ted Berger stated that we did realize. They were missed in the design and one was added by Sacred Heart. We do have the street lights. They all have been purchased already. It is just the installation.

Mr. Julio Guridy asked if it cost \$5,000 just to install it. You said you have the street lights already. He stated that in that area they are planting trees, and asked is that only for that block.

Mr. Ted Berger stated that it is not just the light itself. It was to install a street light, construct foundation for another light pole, the junction box and the work required. It is the new pedestrian lights. The item itself is \$1,200 to install a street light. We are putting pedestrian lights from 4th all the way up to 7th Streets.

Mr. Glenn Hunsicker asked if the Change Order #2 was in the original

estimate. It wasn't in the original design. If you don't approve it, is this work already done? He asked about Change Order #1, \$92,000. What was that for? Why wasn't that in the original order? He asked about the architect or did the city do this.

Mr. Ted Berger stated no. That is why the Change Order. He stated that it was for additional handicap work that was required to install handicap ramps. He stated that the problem that happened with the ADA requirements the original design had the handicap ramps that needed a dome on the corner. He stated that this was a private contractor.

Mr. Ray O'Connell asked if there were any other questions from the public on R151.
