Mr. Lou Hershman, 405 N. Gilmore Street, asked the status of the Vehicle Policy. He talked about malfeasance by the Mayor and Finance in presenting a balance budget that wasn't balanced to City Council. He talked about the pay to play and if they would have jumped on it in 2009, we would not be in the situation we are in today.

Ms. Jan Keim, 11 W. Pine Street - Salisbury Township, talked about the Little Lehigh Watershed. She thanked Mr. Hendricks for attending the Planning Commission meeting in May. She provided the plans of the development to Council. This is a very crucial area. The city already purchased wooded areas. Every acre is very important. She urged Council to get in contact with the Wildlands Conservancy.

Dr. David McGuire stated that he already met with city staff about this parcel of land and the adjacent one that might be available.

Ms. Diana Fandle, SW 26th Street, stated that she is here tonight with about 20 other neighbors asking Council to save their mountain. They have been in front of the Planning Commission on March 21, and June 13 to protect the 13 acre development of Appel Street and Barns Lane. We want to protect the mountain from erosion. They asked for a hydro-study to be done because of the springs and the seepage and the creek that runs along and flows through the Lehigh River.

Mr. John Lutje, 935 N. 17th Street, stated that he was here July 19 and received a call the following day that someone was going to check the bamboo. He is concerned. His family has been living there for 47 years.

The bamboo is 20 feet high and four or five rows. He asked if Council can send someone down and what his options are.

Mr. Ray O'Connell stated that this gentleman has been here before and has concerns. He asked if someone in the administration should get him an answer.

Mr. Brent Hartzell asked the address.

Mr. John Lutje stated it is 929 N. 17th Street and N. Cable Street.

Dr. David McGuire stated that this gets to quality of life. This is not the only type of evasive plants that take over our yards, alleys, and parks. The gentleman understated the difficulty of trying to get rid of bamboo. He asked for a direct report to follow up.

Mr. Kenneth Heffentrager, 214 N. St. Cloud stated that as of Monday no City Councilperson had sent back an email of when the walk was good. He noticed the Mayor having a walk on Muhlenberg.

Mr. Ray O'Connell stated that some of us were on vacation. We will pin down a date and walk with you.

Mr. Kenneth Heffentrager stated that the Alternative Gallery is very involved and they are in Arts Fest at the end of September. He talked about Waste Management and asked if a city official can see what they do at night. The amount of trashed dumped into the middle of the streets. He stated that the police department needs to get a little more friendlier. He has been stopped six times.

Mr. Denzel Morris, 724 N. Front Street, talked about Elias Farmer Market at 101 W. Tilghman Street, directly abutting his property. There are about 18 violations of your codes. He stated that it is a 12 foot sidewalk on the Front Street side, the cars block the entire 12 foot sidewalk. The City Council approved the encroachment in 2016. They just installed the wheel-stops. They are operating a trucking terminal outside our house, staging and loading of 18 wheelers. These trucks that are there idle the entire time. They completely took down the fence that separated our property. There is no buffer strip. There is only trash and an outhouse, an entire dumpster that is not enclosed. He wants a taskforce or committee to address all these violations.

Mr. Ray O'Connell asked if there were any comments from his colleagues.

Ms. Candida Affa asked if Mr. Morris has videos of this.

Mr. Denzel Morris stated eight videos. The link that is on the paper you can go there. The trucks vibrate my house.

Mr. Ray O'Connell asked if he lives on Front Street.

Mr. Daryl Hendricks asked if Mr. Morris brought his complaints to Code Enforcement.

Mr. Denzel Morris stated that indeed he has. He stated that he was talking to Engineering and Zoning. He stated that he brought the matter to Code Enforcement.

Mr. Daryl Hendricks asked if Code Enforcement came out.

Mr. Denzel Morris stated that the Enforcer was on vacation and then I was supposed to go back the next week to set up an appointment. He did not want to set up an appointment with me.

Mr. Daryl Hendricks stated that one of us will give our copy to Mr. Hartzell and he asked that Mr. Hartzell make sure that it goes to the proper contact.

Mr. Brent Hartzell stated that he would be sure to get it to both Public Works and Community and Economic Development.

Mr. Jeremy Warmkessel, 936 Hawthorne Road - president of the Local Fire Union, stated that back in April we approach this body on where we were with our fire apparatus. With budget season coming upon us in the fall, I wanted to say what has taken place back then. We made pretty bold statements and follow up with a social media campaign. The Mayor said that there were no problems and since that time there was an emergency purchase order and we brought a demonstration fire engine. That is a good step, but that piece of equipment came with no generator which is the only piece of equipment that does not have a generator. It was too big to go to the place we were replacing it so we had to move it to another bay. We have problems with our Fleet Provider on how they respond with our maintenance issues, mechanics that work with them that did not have EVT (Emergency Vehicle Technician). We were able to get police and fire for the RFP process. There will be a new maintenance contract. The Public Works Director can still administer the Fleet Contract. That is a poor practice. We recommended that they use the Risk Manager. We were able to put the EVT in. The responsive of our garage, we were getting nowhere with them. Now, they are very responsive. We need two additional engines in the upcoming years to be part of the Fleet Replacement Plan. Our reserve engines are from 1994, 1995 and two

from 1999. Their lives are over. You will have a hard time finding parts, replacing, and fixing.

Mr. Ray O'Connell thanked Mr. Warmkessel and stated that he and Mr. Hendricks met with him once or twice. He will continue to make the commitment on whatever the fire department needs we will fight very hard for.

Mr. Julio Guridy asked for a copy of Mr. Warmkessel's report.

Mr. Jeremy Warmkessel stated yes, and it is on Facebook.

Mr. Roger MacLean stated to Mr. Warmkessel that you are looking to replace tow trucks. He asked what would you ask for Ariel trucks, and Pumper Trucks.

Mr. Jeremy Warmkessel stated that question is suited for the Chief, but in his opinion is engine replacement. We run a lot more miles than NFPA recommends. We are busy.

Mr. Jeff Glazier stated that in the current budget we made the last payments to the fire vehicles. One was payment number 7 and one was payment number 10. The five year capital plan Council approved there were two vehicles in that for the 2018 year.

Mr. Glenn Hunsicker, 844 S. 11th Street, stated that there was a Pension Board meeting and asked for a summary of that meeting put out online. He said in that it would be the liability/asset ratio. The amount of money invested in our pension.

Mr. Ray O'Connell asked Mr. Hartzell if he had a comment or suggestion on Mr. Hunsicker's request.

Mr. Brent Hartzell stated that Mr. Hunsicker attended meetings before and he has a very long standing interest in this. There will be some minutes that will be forthcoming that would eventually get approved. Because of the recent investment gains in police and fire we are at our highest levels of funding in those particular funds in the establishment of the Water/Sewer Lease.

Mr. Glenn Hunsicker asked if it was a time limit on those minutes.

Mr. Brent Hartzell stated that he will follow up with Mr. Glazier on that.

Mr. Ray O'Connell stated that we will let you know when we have more

concrete information.

Mr. Daryl Hendricks stated to let Mr. Mike Hanlon know.

The Committee has not met since the last council meeting; a meeting will be scheduled shortly.

City Controller's Report

Mr. Jeff Glazier stated that he has two audit reports. One is on Lights in the Parkway and the other one was the Lead Base Paint Hazardous Control Program. The interns did the process flow a couple of weeks ago and these are the audits that they also did. In two weeks, I will have some bank reconciliations as well. They documented the revenue process flow for the Lights in the Parkway to identify any potential risk and weaknesses. This was the first year that the Parks Department use the Event Brite and we think it was a great step forward. No formal sponsor advance ticket reconciliation of the un-used tickets. There were questions on Event Brite sales reconciliation. Parks and Recreation should partner with the

Treasury Department to develop a reconciliation procedure. There was not a Lights in the Parkway operations manual for certain events. The recommended a cash counter machine and save on payroll. The use of an automatic card counter at the ticket booth. The administration plans to implement an automatic vehicle counter in the 2017 season. The other audit was the Lead Based Paint Hazardous Control. The grant specifies that a different bank account has to be a non-pooled bank account. The current administration is currently changing bank account from Wells Fargo to TD Bank. We note some reporting inconsistencies. Expense classification should be consistent. There is a \$25 discrepancy between the reports and supporting documents. He thanked the departments for their timely responses. He stated that in regards to Mr. Hershman's question, the ordinance only talks about the sedans going home which is a significantly narrower question. It is beyond the scope of the ordinance.

Mr. Ray O'Connell stated to Mr. Glazier that once we have a handle on the Ordinance and what does it affect it fleet-wise and to make a new Ordinance to narrow.

Mr. Jeff Glazier stated or broaden. He stated that the solicitor's office might want to share that with you and you can have a discussion with the Solicitor on how best to address the issue that might come up.

Mr. Roger MacLean stated that Mr. Hershman's question is how many vehicles are going home, outside of the city.

Mr. Ray O'Connell stated I think you are right.

Mr. Jeff Glazier stated that there is a specific ordinance. Does the mayor have authority to do certain things. When you audit, you audit on a standard whether it is an AIM or Ordinance.

Mr. Roger MacLean stated that he has to respectfully have to disagree because he thinks it is real simple. Each department head gives a list of how many vehicles are going home outside the city.

Mr. Brent Hartzell stated that the Lead Based Paint and the bank account that it is a condition of the grant that it needs to be in a separate bank account.

Mr. Julio Guridy stated in regards to changing the bank account from Wells Fargo to TD Bank. What accounts are they planning to transfer.

Mr. Jeff Glazier stated that an RFP went out for banking services for the city beyond that.

Mr. Brent Hartzell stated that he just put his signature on a whole lot of accounts that will be established with TD Bank. TD Bank was selected as a result of the RFP.

Ms. Cynthia Mota asked if we make that move are we going to be saving and how much money. She asked if there will be any charge that will take place or penalties.

Mr. Brent Hartzell stated that he allow Ms. Bowman to provide a detail on that. He stated no.

Mr. Lou Hershman stated that there are 13 cars that the Ordinance reads, but it doesn't count the police detective cars. There is a limit to go home.

Mr. Candida Affa stated that she would like to send it to our Solicitor, Ms. Susan Wild for an explanation.

Ms. Susan Wild stated that these proposed amendment came about as a result of an organizational meeting of the Nuisance Abatement Board and upon my recommendations these amendments are being proposed to

extend the time for a hearing on an appeal from a public nuisance determination for 45 days to 90 days. The extension is primarily a logistical manner of convening a meeting and taking consideration request for postponement by the property owner and the members of the board. There is also an amendment that deletes the requires of posting a \$5,000 bond if an appeal is filed there will be no bond required at that stage of the proceedings. There only would be a bond required following a determination of the Nuisance Abatement Board if a further appeal is taken to the Lehigh County Court of Common Pleas. The amendments also includes a provision that was overlooked that each member of the board needs a designated alternate in case a member of the board is unable to serve because of a conflict and each member of the board has to have a specific alternate.

Mr. Ray O'Connell thanked Ms. Wild and asked if there were any comments from my Councilmembers or the public.

Mr. Kenneth Heffentrager stated that 45 days and 90 days determines if they need an extension.

Ms. Susan Wild stated that the hearing itself has to be held within 90 days.

Assistant Chief Gail Struss stated that she is here seeking approval to hire Mr. Tamburello as an Allentown Police Officer. He has gone through all the testing and we have a tentative start date on Monday. He is a 36 year old resident of Easton and is an ACT 120 Police Office and an Army Veteran.

Mr. Daryl Hendricks asked if he is currently employed at a police department.

Assistant Chief Gail Struss stated no.

Ms. Candida Affa asked is he an officer from Easton.

Assistant Chief Gail Struss stated no. He is in the private sector working. He went through our Police Academy.

Mr. Julio Guridy asked what number is that. He asked if the city budgeted for 220.

Assistant Chief Gail Struss stated that we are short 12. With Mr. Tamburello we will be short 11. She stated 222.

Ms. Cynthia Mota asked whatever happened to hiring Allentownians. We did talk about that. I know that other police departments have police presence in many different high schools to talk about the benefits of being a police officer.

Mr. Roger MacLean stated that the Civil Service Rules dictate how we hire police officers and the Civil Service Rules doesn't include that they have to be a resident of Allentown.

Ms. Cynthia Mota stated that we did talk about Allentownians. She stated that she does understand that the military gets five more points, but we did talk about that. If the police officers goes into our school and promoting something should be done.

Assistant Chief Gail Struss stated that they are trying to hire. They are having a hard time recruiting people in general. Not just people in the city, but people in general that wants to be police officers.

Ms. Cynthia Mota asked what seems to be the problem. When you have the Academy how many students do you have.

Assistant Chief Gail Struss stated just people not wanting to be police

officers. We are not be portrayed in a good light lately. It is not just our department, it is nationwide. She stated that they have anywhere from 20 - 30 in each Academy Class.

Dr. David McGuire stated that there is an appeals board of a candidate for a vacancy in the Allentown City Police Department which the hearing was scheduled on July 5 and the candidate showed up with his attorney and with several witnesses, but the did not have sufficient number of officials for it. The whole thing had to be canceled.

Mr. Ray O'Connell stated that it is irrelevant for R154.

Ms. Susan Wild stated that she would agree with that, but knows that it is a personnel matter that probably should not be discussed in this forum.

Mr. Ray O'Connell asked if there were any other questions from Council on R154 or the public.

Mr. Ed Zucal, 650 N. 16th Street, stated that as most of you know I am a retired Allentown Police Sergeant and for the last seven years of my employment I was the main background investigators. The main problem with the Allentownian issue is that there is no residency requirement. They can't force people to live in the city to work for the police department. When it comes to hiring people I got three books this thick. At one time we had a hiring list when Chief MacLean was here with about 300. In order to get 20 we were upping the numbers to 175.

Mr. Ray O'Connell asked if there were any comments from his colleagues.

Mr. Julio Guridy stated that this Resolution particularly to hire the attorney.

Mr. Ray O'Connell stated correct. To get outside Counsel.

Mr. Roger MacLean stated that he is voting no because he has worked in the criminal justice system for over 40 years. The criminal justice system is moving forward and I think the criminal justice system should move forward and answer these questions. That is why I am voting no. I think it would be redundant and a waste of taxpayers money.

Ms. Cynthia Mota stated that she is also voted no. Like everyone else I want this nightmare to end, but I do believe in our justice system and a reason why I am voting no. I do agree that we are wasting the taxpayers money. The case is moving forward.

Mr. Julio Guridy stated that we did not put this in the Resolution, but I would have probably considered this more if we would have put an amount on how much to spend.

Mr. Ray O'Connell stated that we have it in our budget to hire outside Counsel. We put aside \$40,000. He asked Mr. Hanlon what is the amount?

Mr. Julio Guridy stated that it is in our budget, not this Resolution.

Mr. Mike Hanlon stated that he would assume that Council would have to come back and pass another Resolution with a number in it.

Mr. Ray O'Connell stated that when we actually go forth and hire an attorney.

Mr. Julio Guridy stated that the Resolution normally if you are going to spend money you will put an amount on how much you are going to spend.

Mr. Mike Hanlon stated correct, but that would be another Resolution.

Mr. Julio Guridy stated that makes it difficult because I would have thought this Resolution would have the amount because it is authorizing us to hire an attorney.

Dr. David McGuire stated that we are authorizing someone to be hired just like we authorize a consultant for the swimming pool to be hired. Thereafter, we make an arrangement is there money in the budget and how much.

Ms. Candida Affa stated that what we would do is an RFP out for an

attorney.

Mr. Mike Hanlon stated that you would go through the purchasing process.

Mr. Daryl Hendricks stated that he understands and respects his colleagues opinion and certainly Chief MacLean. He stated that he too was in law enforcement for a long time and in almost 40 years he has arrested a lot of people and I know Chief MacLean has and Sergeant Zucal has, but I can say in those 40 years I arrested anybody and charge them with 54 counts of anything. I will be voting for this. The Mayor's actions has caused a stain, a stain that will forever leave a blemish on the fabric of our city regardless of the outcome of a trial if it should go distance.

Mr. Ray O'Connell thanked Mr. Hendricks and asked if anyone else from Council had a comment.

Mr. Julio Guridy stated that this Resolution has some good points in it. I would rather have done two Resolutions. One is asking the Governor, which I don't think he is going to do anyway to remove the Mayor and the other one would have been the legislative part of it asking the State Representatives and Senator to change the way the system works as dictated in the Resolution.

Mr. Ray O'Connell stated that is in the Charter. We fully realize that it would have to be a Charter change. Amending the 2017 Equipment Fund by appropriating the remaining balance of the 2015 short term loan funding in the amount of Six Hundred Eighty-Six Thousand Seven Hundred Ninety-One Dollars and Eighty-Seven Cents (\$686,791.87) for IT and Police Projects. The bill allocates funds for Information Technology and the Police Department for the purchase of in-car cameras, body cameras, additional city-side cameras and a records management system. IT plans to purchase a voiceover phone system, archive system and replace network switches and other computer equipment.
