City Controller's Report

Mr. Jeff Glazier stated that he has a couple of audits. The first one is a bank reconciliation from March 2017. Three basic findings: an issued check was not recorded on the books. A check for \$59,000 was issued and paid in the curb and sidewalk bank account, but was not recorded in Eden. There were two checks totaling \$5,300 that were not cleared in Eden. The third finding was there were some checks that were not voided on the bank listing. There were 29 checks totaling \$590,000 that were

voided on the Accounts Payable Cash Sub in Eden. There were five checks totaling \$11,000 that were voided on the Payroll Cash Sub in Eden. Over the past two weeks, my office reviewed the various registered funds. We audited those to see if everything was accurate. These audits are merely a snapshot in time. Revenues and audits were performed on the 19th of September. Fire Administration was performed on the 20th. He released the Fleet Audit two weeks ago. It is on the website. There are 13 sedans that are allowed to go home and no more than 13 sedans are going home at this period of time.

Dr. David McGuire asked about the 13 and unintended language with cars and sedans. He asked if 13 is the number of sedans, and not SUVs. Are there any SUVs that are taken over the city lines without permission?

Mr. Jeff Glazier stated none are SUVs. That was beyond the purview of what we looked at. It is not a matter of the Ordinance. The Ordinance limits sedans, not SUVs.

Mr. Ray O'Connell stated that Mr. MacLean has asked questions along with you. We have to revisit the Ordinance.

Mr. Mike Hanlon stated that there is a draft floating around.

Mr. Jeff Glazier stated that he spent time with the able bodies in the Solicitor's office to determine what the meaning was. I need to audit to a standard. Language has meaning. The Ordinance was written for sedans.

Mr. Julio Guridy asked Mr. Glazier if he checks to see if the audit findings are also corrected.

Mr. Jeff Glazier stated that he speaks with the Finance Director on a regular basis.

Assistant Gail Struss stated that Alexander Kiskeravage is a 23 year old born and raised in Allentown. Currently, living in Northampton. He will bring our number to 212. He is currently employed by our Communication Center. He has been working from May 2016. He has to go through our Police Academy and he is in the Marine Corp.

Mr. Julio Guridy asked if we are hiring officers that have not passed the exam and not on the list.

Assistant Gail Struss stated that it is not a requirement to apply. We will put you through the police academy.

Mr. Daryl Hendricks stated that we are 10 short of our total number. How are we doing on those 10? Do we have others in the pipeline?

Assistant Chief Gail Struss stated that we have at least one more that should be coming to you within the month. We are still going through the current list.

Mr. Daryl Hendricks asked how many were on the list in total.

Assistant Gail Struss stated 90 + that were on the list.

Mr. Julio Guridy stated that at one time we had 1,200 people on the list.

Mr. Daryl Hendricks stated not on the list. Maybe who took the test.

Mr. Ray O'Connell asked if anybody on Council or the public had any comments on R171.

Assistant Gail Struss stated that this is an annual grant we get from the DOJ. This is a little unusual. The grant requires that we go in front of City Council before we are actually awarded the grant. We believe it is around \$57,000 and some of the money is shared with Lehigh County. It will save our staff, especially our Desk Sergeants a lot of time.

Mr. Julio Guridy stated that it is good software. We use it where I work. You do fingerprints on it and it keeps people honest.

Assistant Chief Gail Struss stated that she would hope that they would not have that problem in the Police Department.

Mr. Daryl Hendricks asked if this grant would fund a drone. We are using cutting edge technology.

Assistant Chief Gail Struss stated that it is what the county is looking at from their share of the money. The county does have something, but I don't want to get into details because I am not exactly sure.

Bill 58 Public Safety, Recommended Favorably
Amending the 2017 E-911 Fund Budget by transferring One Million (\$1,000,000) Dollars from the unappropriated balance of the E-911 Fund for the down payment on the radio system upgrade. The 2017 financial impact is the \$1,000,000 down payment to Harris. PEMA is allowing the use of \$1,200,000 of 911 funds toward the purchase of this equipment. \$1,000,000 will be used as the down payment to the vendor, Harris, and the remaining \$200,000 will be paid in 2018 toward the debt service of the loan. Starting in 2019 there will be an annual payment of \$535,308 divided among the 4 funds that use the radio system for the next 5 years.

Mr. Ray O'Connell stated that Mr. Dennis Wetherhold is here. He stated that we will be referring it to Committee.

Mr. Dennis Wetherhold stated that our current radio system here is 17 years old. The technology as of December will no longer support it. Over the years, we upgraded Police, Fire, and EMS radios to stay with technology. The majority of Public Works, Parks, and all the Public Works

workers radios have never been updated. It gets us up to FCC compliance. They all get new radios. The million dollars that's there is 911 money. We had a million dollars that PEMA said to use it or they would take it back. Radio infrastructure is part of what you can use 911 monies for. We found a way to move the upgrade forward.

Mr. Ray O'Connell stated very good job Mr. Wetherhold. We don't see much of you, but you did a very good job. He asked if there were any comments from his colleagues or the public.
