Mr. Brent Hartzell stated that Ms. Snyder will give the details and Mr. Shahda is here to go into the technical aspects, if necessary.

Ms. Judy Snyder stated that it was advertised on September 12, 2017. The bid opening was December 4, 2017. There were two bidders and Ferguson came in at \$113,843.35.

Mr. Ray O'Connell asked if this work would have been done regardless of the stormwater fee. This is work that negates the stormwater fee.

Mr. Mark Shahda stated that this is work that will be done regardless of what takes place tonight. This is for our underground infrastructure to take care of all the necessary repairs below the surface.

Mr. Ray O'Connell asked if there were any comments from his colleagues.

Mr. Daryl Hendricks about about the single bid, and is that normal for this and do they specialize.

Ms. Judy Snyder stated that they are basically specialized for that one. Neenah does the inlet and the man-risers. This was just the piping. I have the bid tabulation and they did not bid on it. It was a no bid.

Mr. Ray O'Connell asked if there were any other comments from Council or the public.

Mr. Tom Hahn, 2016 E. Highland Street, asked if this type of contract is a once and done.

Mr. Ray O'Connell stated that Mr. Shahda can answer, but believes it is a once and done.

Mr. Mark Shahda stated that it is a one year contract with the option of extending it for three additional months.

Mr. Tom Hahn asked if that will cover the extra material that they need. He asked if this includes the manhole covers.

Mr. Mark Shahda stated yes, that is correct. We can go above or below our estimated quantities within the contract.
