Mr. Lou Hershman asked about the new mayor and if he is going to release the five year financial plan. He stated that you work with the District Attorney and attack the opiod problem in Lehigh County. He asked how the City of Allentown is attacking this problem. We need to look at the homeless problems.

Mr. Roger MacLean stated that he will get with Mr. Hartzell tomorrow. He stated that he is not speaking in an official capacity from his day job. The City of Allentown Police Department is working hand and hand with the county on the opiod crisis. This problem is attacking every socio-economic growth.

Ms. Cynthia Mota stated that it is an epidemic.

Mr. Lou Hershman stated that Council should look at how we appoint a mayor. We have a City Controller position appointed. He requested to get another opinion.

Mr. Roger MacLean stated that they are getting a Charter Commission going.

Ms. Kim Oliver, 350 Hanover Avenue, stated that she had complaints on what the city has not done. They allowed structures to be built without permits. This has caused problems because the fee structures are illegal and not up to the IRC and on my property. She stated that she has been emailing everybody and this has been going back a long time and they continue to do it. She stated that 352 Hanover Avenue did not get any

permits on the structure they built. These structures are unsafe. She stated that 348 Hanover Avenue has a chimney leaked.

Mr. Roger MacLean stated that Council will get an answer from Building Standards.

Mr. James Whitney stated that both Roger MacLean and Ray O'Connell have the experience necessary and skills to lead our city. We are a little confused when we are reading things on The Morning Call and WFMZ about the eligibility that they have. We you inquiry they said it depends on how they interpret the rules. He suggested that they do a safe, clean appointment. He suggested Council choose Charlie Thiel.

Mr. Roger MacLean thanked Mr. Whitney for his kind words.

City Controller's Report

Mr. Jeff Glazier stated that he has three audits. They did an audit in Risk for the Inland Marine Insurance. The City of Allentown purchases insurance to cover pumper trucks, ladder trucks, rescue vehicles, hazmat vehicles, and freight liners in Public Works. The objective of this audit was to determine whether the payments made to Harleyville Insurance - Nationwide for premiums was in compliance with the contracts. Determine whether the invoices properly categorized for billing purposes and determine whether the terms of the contracts were in compliance. The first finding was: Contract Renewal Rate Weakness, the Agreements were not forwarded to the Controller's office. He talked about the Accountants Payable Weekly Check Review from January 21 to March 2. The Golf Course agreed to establish an acceptable protocol for ticket distribution. Sales tax was paid on two invoices. Incorrect expense account was used on 11 checks. The departments were advised on this. There were 24 untimely payments of invoices. Bank Reconciliation Review for the month October 31, 2017 Finance is working really hard to catch up to the end of

the year. There are a couple of new findings: Inaccurate bank reconciliation, payroll bank reconciliation is a three part reconciliation. The second new finding is unreconciled differences on the bank reconciliation. There was a voided check in Eden that was not properly posted on the cash sub.

Mr. Julio Guridy asked Mr. Glazier if he will be looking into the findings of the CAFR Report.

Mr. Jeff Glazier stated on a regular basis he and the Finance Director have a discussion on that. He stated that he encourages him and the department to make as much progress as possible.

APPOINTMENTS: Ce-Ce Gerlach - Parks and Recreation Board, December 31, 2018 - submitted by the School Board.

Mr. Hendricks stated that he know Ms. Gerlach and worked with her. She is most deserving of this position and congratulate her. She will certainly be a benefit to the board.

Mr. Roger MacLean apologized for the delay.

Mr. Courtney Robinson stated that he is happy it got resolved so that we have not set a precedent that many members of Council would not have agreed with. He is happy it moved forward and we have a Resolution. He thanked everyone involved and stated congratulations.

Mr. Julio Guridy stated that it is about time and he is glad that she wants to give more of her time to the community.

Ms. Cynthia Mota congratulated Ms. Gerlach and stated that they have a lot to do. Welcome on board.

Ms. Candida Affa congratulated Ms. Gerlach.

Mr. Ed Zucal congratulated Ms. Gerlach and stated that she is a positive influence in both the school's and the community.

Ms. Cynthia Mota stated that they met on February and forwarded without recommendation.

Mr. Roger MacLean asked if there were any comments from Council.

Mr. Julio Guridy asked why they did not come to a decision, no recommendation.

Ms. Cynthia Mota asked Ms. Taylor to speak on Bill 9.

Ms. Lindsay Taylor stated that she believe that the Bill was forwarded so the entire Council can consider it. Several things are going on in the Parks System via projects and issues that cause us to take a look at the Parks Regulations Ordinance and recommend various changes to it. There were four or five significant issues that we looked at. She discussed the issues.

Mr. Julio Guridy stated that they are great ideas. Do we have a section for people that want to bring their own grills.

Ms. Lindsay Taylor stated that if you rent or reserve a pavilion you can bring your own grills. Sometimes they leave them behind. They leave broken grills, broken tents and broken chairs and we spent most of the day Monday cleaning on things that are left behind.

Ms. Candida Affa asked if the city added more grills. She asked about more patrols.

Ms. Lindsay Taylor stated at Jordan Park they added more Pavilions and grills.

Mr. Roger MacLean stated that they sent this to full Council because there were a lot of changes.

Mr. Julio Guridy stated that in the past couple of years there have been people coming from outside the Lehigh Valley using our parks and creating a lot of problems. In Bethlehem, at Saucon Park, they had to close the park several times. In Easton and Nazareth, they had to close their parks. People need to adhere to our laws.

Ms. Cynthia Mota stated that she agrees with Mr. Guridy, but the public needs to be educated. If we are going to do something, we have to enforce it. We have to give out more tickets and have more manpower. There are rules, but if you don't enforce it, then what?

Mr. Roger McLean asked if there were any other questions from Council or the public.

Ms. Valerie Chambers stated that she is against the prohibiting of the swimming in the creek. She grew up here and swam in the creek. Why

can't you just enforce who is there? We are not letting certain people and certain people are being sought out. Why we just can't enforce? She stated that she wants Allentown to be inclusive.

Mr. Roger MacLean stated that they are being inclusive, we are just asking people to follow the Rules. He stated that he remember swimming in the creeks 30 - 40 years ago, but we are in a more litigious society.

Mr. Daryl Hendricks states as Mr. MacLean said we are not excluding anybody it is just that we are going to put certain rules and they are getting over-used and it really taxing our police department, the park property and services of the city.

Ms. Candida Affa stated that last year she made a point to go to Jordan to swim and see the difference on the weekends. On a Monday, it take an entire day of the crew to clean up. It was mostly out of state license plates during the weekend.

Ms. Cynthia Mota agreed with Ms. Chambers, but stated that it is horrible to see a child almost drown.

Mr. Julio Guridy stated that General Trexler who had agreed that we were to keep our parks right.

Ms. Lindsay Taylor stated that it is a change for us. We had a straight across the board fee and we switched that last year by implementing a hot weather advisory regarding residency. With the change in the reopening at Cedar Pool we will again face pressure from nonresidents both local and far away and we want to be prepared for that. Allentown School District does issue IDs that the students keep. You can purchase season passes and you are good for the season. IT has a residency App that they can implement the policy.

Ms. Cynthia Mota asked if they will have more staff. She asked if Ms. Taylor foresees any issues since they have a new pool.

Ms. Lindsay Taylor stated that they will have the same gate attendant. The staff will be prepared for that.

Mr. Courtney Robinson thanked Ms. Taylor for responding to the questions he posed to through Mr. Hanlon. Cedar Beach will be the same for hot weather where you will have the discount rates for residents. He stated that he supports having the different fee for nonresidents. He stated that he is happy that the city is working with the school district, but what are we going to do concerning students that are home schooled, chartered schooled, or home schooled.

Ms. Lindsay Taylor stated it will be the same as Jordan and Mack. She stated that part of it is promotion of the policy and working with the parents.
