Mr. David Keshl, Wabash Street - President of Moutnainville 30 Crime Watch, stated that he has two concerns with safety about the concrete barriers on Hamilton Street and 4th Street. They are not painted anymore. They are very hard to see. He asked for paint or reflectors. He asked who takes care of parking on sidewalks. Does the police or traffic or Parking Authority.

Mr. Roger MacLean stated that it is the Parking Authority and the Police.

Ms. Candida Affa stated call the Parking Authority. They are there until 5:00 PM. She stated that she will address it at the Parking Authority's next meeting.

Mr. Chris Woods, Walnut and 10th Streets - Allentown Coalition for Economic Dignity, stated they met with Mayor O'Connell about a month ago. Since that time, we tried to reach City Council to meet with you to talk about the same six proposals that we gave to Mayor O'Connell. He stated that he emailed all of them at least once. Some of you twice and reached out to Ms. Whitehead. He stated that he heard a response from Mr. Hendricks and Mr. Zucal only to say that the date did not work. The other five of you I have not heard from. He stated that they will be persistent to meet with Council on affordable housing.

Mr. Roger MacLean stated that he is way behind on his emails and you can't meet with all of City Council.

Mr. Chris Woods stated that he is hoping to meet with them individually.

Mr. Roger MacLean suggested that Mr. Woods contact Tawanna and she can check our schedule and coordinate more than one meeting. It would have to be two or more.

Mr. Courtney Robinson echoed what Mr. MacLean said and stated for his industry summer is the busiest time. He asked if Mr. Woods would be comfortable having at a public meeting.

Mr. Chris Woods stated that yes. Mr. Courtney Robinson stated that he would be more than happy to work the schedule for Community and Economic Development meeting and asked for everyone to be present for that.

Mr. Julio Guridy stated to Mr. Woods if you need to talk to me you can call on my cell phone.

Mr. Ray O'Connell stated that he did meet with Mr. Woods and his group and that is a good suggestion.

Ms. Erika Bickford, 130 S. Lumber Street, thanked Mr. MacLean for looking at the stairs. It would be far cheaper to pay \$50 - \$100 to fill the cement gaps on the top of S. 11th Street then to have a lawsuit. I am still having pain from when I fell. She suggested to add a rail.

Ms. Paulette Kish, 1028 E. Chew Street, stated that there is a recycling issue where a tepee has been left on a curb for over a month. Recycling said they won't pick it up. It is at 1020 E. Chew Street. She asked about the swimming pools and lifeguards pay. If you pay your lifeguards you will have a much better chance of having lifeguards at your pools. She stated that the biggest issue is that she read in the paper that Lindsay Taylor was let go. She is concerned that the project Ms. Taylor was working on at Andre Reed park. Her concern is everything that they work on as was established is going forward.

Mayor Ray O'Connell stated that it would still go forward. The spray park is the suggestion on the committee. That will continue to move forward. He stated don't believe everything you read in the paper.

Ms. Jennifer Miller, 1120 Club Avenue, stated that her two dogs got attacked by two loose dogs in the park. She stated that she was trying to contact the police department and file a police report.

Mayor Ray O'Connell stated that she did not catch her name or what her complaint is.

Mr. Roger MacLean stated that Ms. Miller's dogs were attacked by two dogs in the park.

Mayor Ray O'Connell stated that if you contacted the Mayor's office this is the first time I am hearing about it.

Ms. Jennifer Miller stated that she is working with Animal Control and they are pressing charges.

Mr. Roger MacLean stated that the Mayor will see that Captain Keiser contacts you.

Mr. Louis (inaudible) stated that he lives at Franklin and Fairview Streets and there is a hydrant and the cars are parked away from hydrant. He gets tickets. He stated that the corner should be painted in yellow.

Mr. Roger MacLean stated that it doesn't have to be painting. You can't park within 15 feet of a fire hydrant. He asked Mr. Messinger to have lines painted at the fire hydrant.

Mr. Craig Messinger stated that they are actually going to paint all along the fire hydrants.

Ms. Candida Affa stated that this is how you get your driver's license. You have to know that.

Mr. James Whitney, 1122 Hamilton Street - Little Drills Creative Studios LLC, stated that his partner Shelby owns 1122 Hamilton and 65 Oak and is a small business owner running a marketing and photography company. She and I moved from Seattle to Allentown and invested in the city. They were awarded a much needed grant from Upside Allentown to upgrade the facade of our commercial building. From day one a collaboration was not an option. We tried to persuade Peter Lewnes to have a facade that would work with our business. Mr. Lewnes reacted by designing a facade that was the exact opposite of what our business stands for. He wanted our business stamped dark grey. Mr. Lewnes cites the committee's strict historic rules. He stated that Upside Allentown's Committee has five principle objectives and not one of them is for historic preservation or accuracy. He stated that Jeff Brace told them point blank the committee has no opinions of what any building looks like. He asked for the city to step up and help them.

Ms. Candida Affa asked if Mr. Whitney wants to paint this, correct.

Mr. James Whitney stated that they want to stain it.

Ms. Candida Affa stated that according to Peter he wanted it back to the original to be brick. The first thing is that it had to be restored and then he changed the rules to yes, you can paint it, but it has to be painted his color or the color he wanted.

Mr. James Whitney stated that Upside Allentown Physical Improvements Committee has no historical guidelines.

Mr. Roger MacLean asked Mayor O'Connell is there someone in the city that Mr. Whitney can work with and navigate through this process.

Mayor O'Connell stated that he and Mr. Whitney talked and it is outside our purview per se because it is a CADCA and Upside Allentown.

Mr. James Whitney stated that HARB does not regulate paint colors. If you have a well with \$550,000 of private funds in it and then you throw a penny of public funds into that well then that money, all of it should be distributed with fairness and equality. Guidelines exist for a reason. The guidelines that you are stating don't exist.

Mr. Roger MacLean asked Mr. Whitney to give his information to Mr. Hanlon and when Mr. Robinson sets up a Community and Economic Development meeting we will pursue it further.

Mr. Courtney Robinson stated that he will work with Mayor O'Connell so that they can have Mr. Lightner and the rest of his staff, including Jesse Sadiua who deals with Upside Allentown. There is a fair mixer of public and private money so there should be some oversight. He stated that he knows there are other issues that have been happening with Upside Allentown. He asked Mr. Kimmerly if the only regulation on Hamilton Street is the demolition overlay.

Mr. David Kinnmerly stated yes, that is correct.

Ms. Shelby Edwards, Little Drill LLC- 1122 Hamilton Street, stated that they create visual context for a living. She provided a rendering of their dream facade for 1122 Hamilton Street. She spoke about Mr. Peter Lewnes email and about painting building. We were staying with a more historic color of darker grey. This design was deemed so historically inaccurate it was worth balking at and revoking the grant that we were awarded. We shared our facade design with local respected historians who each gave their blessings.

Mr. Collins, Summer Intern - Little Drill Creative, stated that he is an intern and moved from Brooklyn, NY and never got an opportunity to get to know about Allentown. He stated that he learned to love Allentown as a true hidden gem. He stated thanks to his employers he was able to see the historic mecca of buildings that deserves to be treated for what they are. They are gems. Allentown is in desperate need for an economic boots.

Mr. Roger MacLean stated he is glad Mr. Collins like it here.

Ms. Cynthia Mota stated welcome.

Ms. (name not given) urged Council to think about this. She stated that she met Shelby and James as a result of her appointment to the Parks Board. They are passionate about Allentown. Their building is beautiful. You want young people to come into the city and revitalize it. Give some consideration to this. This is what Allentown needs. She stated that she hopes Council takes some consideration with this.

Mr. Roger MacLean stated that he can guarantee Mr. Robinson will follow up on this under his committee.

Mr. Enrique Moreno, 33 N. Front Street, stated that he has lived in the city of Allentown for 20 years. He stated that he has so many issues. He represents the Lehigh Spanish Soccer League at Fountain Park. He stated that he paid his house off and pays his taxes every year. He asked for a meeting. They meet each Sunday in the summertime. What happens with the garbage and the bathroom.

Mr. Roger MacLean stated that there is not enough trash receptacles or are you saying there are none.

Mr. Enrique Moreno stated that he talked to Chris Hendricks and he wants to speak to a supervisor about the issue. We have a payment plan. He stated that there are no trash bins and no bathrooms. The ball goes into the river every summertime. We pay for the field.

Mr. Roger MacLean stated that there were issues with the payment. We are not going to build a wall so that the ball doesn't go into the water.

Mayor O'Connell stated that they continue to work with the Spanish Soccer League. There are issues. They have to play by the rules. They have to pay or they don't play. He stated that he goes on Sundays and it is a mess. We are doing the best we can, but they have to play by the rules. If they don't pay, they don't play. We continue to have a problem. They can't drink alcohol in the parks. They have to clean up their acts or they won't be

playing in Allentown next year.

Ms. Cynthia Mota stated that last year she did help them out. I am willing to work with them and willing to do the translation. They have to follow the rules. They are here and stating the problem. She asked when does the garbage get pick up.

Mr. Roger MacLean stated that the garbage is across the field.

Mayor Ray O'Connell stated that we pick it up the next day, Monday.

Ms. Cynthia Mota stated that we will have a meeting on it.

Mr. Julio Guridy stated that he suggested that they come to Council. I just did not have the time. They kept talking to me, calling me and I gave them the information. The issue is that you have to pay in order to use the park. You have to follow the rules. Can we provide the trash basket?

Ms. Cynthia Mota stated that there is a trash can.

Mr. Roger MacLean stated that Councilwoman Mota will work with your guys and set up a meeting with her and the parks department.

She has done countless things and used countless hours from her family to help the homeless and provide shelter for the homeless and collect funds for roofs over their heads. I can't think of a more deserving person than you. He thanked the Skinner family for choosing her.

Ms. Diane Fegley stated that she is super honored and thanked the family. It is appreciated. She stated that with their son, she has been busy. He was diagnosed with autism and we are up to seven therapists. It has been overwhelming. She stated that she does still maintain a Facebook with the Warming Stations. She stated that she would love to be involved in any capacity for the shelter for this coming year. She talked about Chris Cocca bringing the homeless problem to her attention many years ago. He is the one that pointed out that the homeless was sleeping on the floor at St. Paul's right behind the Brew Works. One of the homeless people are here tonight. Working with the homeless is what help you help them. It is the hardest thing working with the homeless knowing that they have a shorter life expectancy and having lost some of our dear friends, including the gentleman that died in the dumpster a couple of years ago. She stated that she is hoping to work with the Skinners and help the true Angels on the street. She stating working with Rooster working with the 800 school children that we have. We did a fundraiser for him recently and the Parish nurse at St. Paul's, Jackie Howells. Her husband actually works for the city. She thanked everyone for their support.

Mr. Roger MacLean stated that this was also in committee and sent favorably to the full Council. He asked if there were any comments from the administration.

Mr. Courtney Robinson stated that this was in Community and Economic Development. They met last week. The purpose behind this is that we need to maximize the rental unit inspections as well as our pre-sale inspections. The money is not currently being used for vacant positions in the electrical/plumbing and building inspectors and combined inspectors because we have some vacancies there. We are going to use this specifically for rental. This is dedicated monies and all for the pre-sale inspections. The Clerk is for the rental inspections, correct? It was brought up by Mr. Hershman of why they are coming in at Step Ds in the budget. These are union positions and we need the full amount budgeted if the

most senior positions could fit into the job. If there are not a senior level, they will be paid less than what is budgeted.

Mr. Leonard Lightner stated presale inspections.

Mr. Roger MacLean asked if there were any comments from the administration.

Mayor Ray O'Connell echoed what Mr. Robinson said. These positions are very, very needed if we want to continue the rental inspections and the pre-sale inspections. A lot of work went into this to present this to Mr. Robinson's committee. I encourage you to vote yes.

Mr. Courtney Robinson stated that if we can work with and it is something that I see living in an historic district seeing a usual problem. The pre-sale inspectors will go through the house and will make recommendations that would have to be brought up to code. An example is porch railings. In HARB, the porch railings have to be lowered. They are in the Code in the historic district because of the historical characteristics.

Mr. Courtney Robinson stated that this was in front of the Community and Economic Development Committee last week and it was forwarded unanimously favorably. This is a situation where security cameras were requested to be put on a building. The HARB meeting was scheduled. The property owner did not show up nor did any representative. A second meeting was scheduled and no one showed up nor a representative. In the meantime the cameras were put up in a way that did not follow the HARB guidelines even though that information had been provided to the property owner. The HARB board brought this up as a denial at the meeting. Representatives of the property owner did arrive. We did explain to them that unfortunately because they did not attend the HARB meeting there is nothing that we could do at this point. I do hope that they spoke to Mr. Kimmerly afterwards to try to move this forward, but because of the timeframe involved we do need favorably vote on this denial.

Mr. Roger MacLean stated that we do have to move forward on this.

Mr. David Kimmerly stated that since the cameras where installed it would be treated as a violation and they would get a violation notice. The option in the violation notice is to remove the cameras or to apply to HARB and discuss with the board methods of trying to make the cameras that currently exist with the cameras fit in. Some of them may need to be removed or some of them may have to be moved to different locations. It may be an idea to paint them and paint the conduit that's also on the building to make them fit in.

Mr. Roger MacLean stated that the homeowner has the opportunity to work with HARB to correct the situation. He asked if there were any comments from Council.

Mr. Nelson (inaudible) stated that cameras that we are working with Mr. Kimmerly and the owner. He stressed the safety and security of the tenants because they are of the most concern. As a result, we contracted secured security of the Lehigh Valley to install high definition eight camera system. Without the cameras present on the building how would we be able to ensure the safety and security of our tenants. To date, at 10:00 AM we had a break-in and a police report was made with the police department. We will lose tenants if we do not have these cameras put up. We would like to take extensive measures to hide the cameras. We are willing to pain the conduit cameras to match the color of the building. This will keep the historic integrity of the building while still allowing us to have a safe and secure environment for our tenants and our community.

Mr. Roger MacLean stated that we want the same thing. Nobody wants you to take the cameras down. What we want you to do is work with Mr. Kimmerly to make sure they fit in the historic area.

Mr. Nelson stated that in the packet he has all the fees. The light camera fee and some information that he wants to leave with Council.

Mr. Roger MacLean stated to leave the information with Mr. Hanlon, but please make sure you work with Mr. Kimmerly.

Mr. Courtney Robinson stated that the HARB guidelines do allow for security cameras and systems to be installed, but they have to follow specific guidelines.

Mr. Roger MacLean stated please make sure you work with Mr. Kimmerly because you are going to have to file an appeal and that will give you time to take care of this stuff with HARB.

We could have waited until November to do all three years which would have been an overwhelming project so we are piecemealing the disposition of the records.

Mr. Roger MacLean stated that his only question is if we got clearance from the courts to be able to do this.

Mayor Ray O'Connell stated yes.

Mr. Julio Guridy stated that this is all records and you have to keep for five years.

Mayor Ray O'Connell stated that we will double-check that, but we are following the guidelines on what we have done in the past.

Mr. Courtney Robinson stated that he has questions on Building Standards records and we are looking at 2008 invoices for safety inspections and 2006 and 2007 for rental licenses and 2005 rental licenses, 2000 - 2004 rental license billing, and the destruction years are from 2011 - 2015. Yes, these are rather old records. He asked Mayor O'Connell when we look at Building Standard we are talking about rental license billing. Do we have if there were violations from a particular property owner, is that maintain in their file separate from the files that we are destroying and can he assume the same for tax records. He asked if everything in the records that should have been preserved are already preserved. Since it is such a large group of records being destroyed I want to make sure of that.

Mr. Hartzell stated that whatever that can meet the criteria of what would be removed. We adhere to that.
