Mr. Randy Beitler, 905 S. Poplar Street, stated that he has new neighbors that live beside him that put a fence up and it appears to be on my property. He stated that he went to Zoning and they gave him block plans. I went to Engineering and they gave him block plans. He stated that he hired a lawyer and he was looking for hundreds and hundreds of dollars. I went to have my property surveyed and I know for sure this fence is on my property and I want to remove it. I want to make sure that I am doing the right thing. I proved to my neighbors that this fence is on his property. Whose fence is it? Do I take it down? The fence is definitely on my property.

Mr. Roger MacLean asked the solicitor.

Ms. Candida Affa asked if Zoning needed to approve the fencing.

Mr. Randy Beitler stated that they do not need a permit for a six foot fence from back step to end of the property line and three feet in front of your house.

Ms. Fran Fruhwirth asked for Mr. Beitler information and the Solicitor's office will research it.

Ms. Janet Keshl, Wabash Street, stated that like Mr. Beitler people are having trouble with new neighbors moving into the neighborhood. She stated that her brother lives on Halstead Street and lived there for 35 years. He has his house up for sale because of the new neighbors. The police has been called and as soon as the police leave it's back to the same crap. My other neighbor on Armour Street is putting their house up for sale. She

stated that she and David are considering it. She has been complaining about 134 W. Montgomery Street for months. It is a rental and the owner lives in New Jersey. These people work on cars continuously.

Ms. Candida Affa asked if it was a rental.

Ms. Janet Keshl stated no, he owns the home and he has friends that come from New York.

Mr. Ed Zucal suggested that she buy a drone and fly it at night so they can see it at their house and they will move out.

Mr. Lou Hershman, 405 Gilmore Street, asked about the Police contract and the raise. When will the money be transferred to the permanent wage account. He stated that Mr. Hartzell was going to check on the bonding to pay for city employees. He asked for an update on Cedar Beach. Are we going to sue anybody? We have to wait.

Mr. Roger MacLean stated that they have to pay them retroactively.

Mr. Brent Hartzell stated that he will look in the documentation, but anytime anything is passed by Council we wait the 10 day period before it becomes an ordinance and make the transfers appropriately. He stated that it was paid six months ago.

Mayor Ray O'Connell stated that he cannot address pending litigation at this time. In the future, I will.

Mr. Roger MacLean stated that sometimes I think we do. When it comes to litigation, yes.

Mr. Glenn Hunsicker, South Allentown, stated that they asked for a special audit and we had considerations presented to the city. He asked for a report where we stand on this.

Mr. Julio Guridy stated that we will have a meeting on Tuesday with the Finance Committee, Mr. Hartzell and Mr. Beckett.

Mr. Don Ringer stated that he stood up here many times and asked for some kind of berm to put around the pool. Everybody ignored it and here we are again where the pool is not operatable. Why can't people listen on City Council or city government listen to logic.

Mr. Julio Guridy stated that he felt very strongly that we should not have spent that money in a 500 year floodplain. However, they assured me they

would put trenches around it. They did.

Mr. Don Ringer, West Allentown, asked why didn't City Council object to the pool. We were building a pool in the flood zone. Why didn't we move it?

Mr. Roger MacLean stated that pool was started before most of us were on City Council and we were past the point of no return when we were hit with changes. We had to authorize the changes.

Ms. Grace Shawood, Allentown, stated that the basic promise of our legal system is equal justice under the law. Those four words are engraved above the doors of the United States Supreme Court and they are not to be taken lightly. She stated that she stands before them as a law student in her last year at Temple University and is dismayed that an attorney should be dismissed for the actions however abhorrent.

Mr. Roger MacLean stated that this will be on the agenda tonight so you will have a chance to speak.

Mr. Louis Holzman, Allentown, thanked Council for the trash can he requested. He bought the property on S. 8th Street and got a certificate of occupancy provided by the city. He stated that he is speaking with Paul Bogart and there are three expired permits on the property. A clear CO was put through. What the inspector said versus what you have on file don't match up.

Mr. Joseph McMahon asked for the address.

Mr. Louis Holzman stated 1001 S. 8th Street.

Mr. Kenneth Laudenslager, 721 W. Cumberland Street, stated that the problem with Cedar Beach Pool is where it is located. They built the pool in 1957 and raised Ott Street. There is a small dike between Ott Street and the pool. The easiest way is to raise that dike as the same level of Ott Street and extend it.

**OLD BUSINESS**

*A motion was made by Courtney Robinson, seconded by Ed Zucal, to Suspend The Rules and bring New Business forward on the Agenda. The motion carried by the following vote:*

*Mr. Courtney Robinson made the following motion under New Business Pursuant to the authority granted to City Council in the city Charter Section 211 B. Council, hereby removes Tom Traud from the position of City Solicitor.*

**NEW BUSINESS**

Mr. Courtney Robinson stated that there are several passages from the public record of the Grand Jury Report that he would like to report onto the Record because he thinks it is relevant from our discussion. From page 25 of the Grand Jury Report, on September 3, 2002, a fax was sent to Monsignors Schlert and Gobitas. The fax bore the timestamp of 09:55 AM from Traud Law Offices. After some discussion regarding an attempt to schedule a meeting with Julianne, Traud reported that he had received information from a relative of Monsignor Leo Fink. This informant told the Diocese that she had been the closest of friends with Julianne in high school and that they shared every secret. She reported that Julianne had once danced as a go-go dancer in the 1960s and that she believed her to be sexually active. Traud's informant stated that she believed it possible that Julianne was one of the girls who had an affair with a coach at Central Catholic. The informant reported that Julianne also had a family member once go to prison. Traud reported all of this to the Dioceses, specifically to Schlert and Gobitas. He went on to note that he knew his informant well and that she had been "so candid and honest." Having received a report that one of their priests had violated children, the Diocese and its attorney immediately began to exchange information meant to discredit the victim with unrelated and irrelevant attacks on her and her family. Moreover, the fact that information that a Central Catholic coach may have been sexually abusing students was used as evidence against the victim. In reality, it is the report of yet another crime not reported to the police. He stated from Page 28, on September 16, 2002, at 2:48 pm, a fax was sent from Traud Law Offices to Schlert and Gobitas. The message contained impressions of the meeting on September 10th. Among other things, the memo noted that Tom Traud found Julianne to be "overly dramatic in the there were some times she was crying in the meeting" and that "this woman made an awful amount of assumptions that just were unwarranted." This pattern of investigating the victim continued through 2004 in letters from Traud dated January 22, 2004, and April 12, 2002. In the first letter to Gobitas and Schlert, Traud noted that Julianne was recently in the news and was

pursuing her lawsuit and that he received information from a local attorney. The attorney told Traud that Julianne's daughter was a witness for the Commonwealth in a murder case. Traud noted that, because Julianne became involved, she could either be "a mother looking out for her child; or maybe this a woman who repeatedly wants her fifteen minutes of fame." In the second letter, Traud informed the Diocese that Julianne's husband was associated with the Christian Motorcyclists Association which Traud labeled the husband's brainchild. This was in reference to Father Fromholzer with Central Catholic and what has been in the news with Julianne Bortz as the victim. He stated from Page 374, and an issue regarding Father Soderlund in 1987. Soderlund continued to minister even after the latest complaint. On April 28, 1987, the Good Samaritan Hospital administrator contacted the Diocese, advising them that Soderlund was spending a lot of time with an eight-year old boy. Soderlund had spend an hour talking to the boy on the telephone, saying that he wanted to take the boy on a trip to a museum. Good Samaritan officials wanted Soderlund to be fired. An excerpt taken from a transcription of a handwritten report from Muntone stated the following: I related all of the above to [the Diocesan attorney] and asked for his recommendation. Much to my surprise, he recommended that the chaplain at Sacred Heart Hospital and Soderlund trade places. I tried to explain to him that that was not exactly the way things worked, that the chaplains are employees of the hospital, etc. He said, that however that may be, Good Samaritan Hospital contributed significantly to Soderlund's problems. He said they should have structured his day more fully, and seen to it that his living accommodations were better supervised, etc. Muntone added that, if Soderlund lived at the rectory at Sacred Heart and "the hospital held him more accountable for his time, there shouldn't be any problems." Muntone responded to Traud's advice by telling the Bishop, "Also if we do manage to place Soderlund after being fired by Good Samaritan we will have an even harder time convincing the others we have no place for them." He stated that this was in reference to a priest that seven years earlier the Diocese had found two photographic albums containing him and two separate underage boys engaged in sexual acts. Seven years prior to this. He stated that the last thing he would like to read into the read into the record is from Council's minutes from our Confirmation Hearing of Mr. Traud on May 2, 2018 at 5:00 PM. Mr. Courtney Robinson thanked Mr. O'Connell and Attorney Traud for being here this evening and thanked Attorney Traud for taking the time to speak to him earlier today. He asked Attorney Traud for a basic rundown of some of the work he had done for the Diocese. Attorney Traud stated that like most lawyers the older you get, the more of an office practice you develop. He stated that once a upon a time he did litigation work and that was gone by the year 2000. At that point, we had attorney now Judge Leeson representing the Diocese for litigation matters going on currently and because our minutes are not a true reflection of what it exactly

says I went back and observed the video and at time stamped 9:30 PM, the exact quote was that was really all gone by the year 2000. At that point we had J Leeson, now Leeson representing the Diocese. As you can see from what was previously read into the record as part of the Grand Jury Report, in 2002 and 2004 Attorney Traud was still doing litigation work concerning sexual assault issues in the Diocese contrary from what he told this body at the Confirmation Hearing. This is not a decision that I taken lightly to bring this forward. I am a practicing Catholic and I am disgusted and appalled of what was done in the name of my faith and here now first and foremost as a Catholic and as an elected official I feel it necessary to apologize to every victim of this and to state that the unimaginable pain and sorrow that you are going through is only compounded from this and I apologize to all of you for that. As someone who is a member of the church that did this to you. I think that needs to be said over and over and over. But, most importantly in result to the business in front of this Council tonight and taking this unprecedented action. Who we choose to have work for us is the statement of the values and the ideals that we hold and for myself as a member of this body and most importantly as a citizen of Allentown, I do not believe that the words that were attributed by Attorney Traud in those faxes and the conversation from Monsignor Muntone represent anything that I as a citizen or a member of this body want our attorney and legal advisor to represent. In that vein I would ask all of my colleagues to please vote yes on this motion and let's finally move beyond the last several years on this city and how it runs. Let's make a statement in saying that we have a new day in Allentown and something like this on top of what we just went through with the corruption trial of the Mayor and his associates will not be stood for. Please vote yes.

Mr. Ed Zucal stated that as elected officials we have an obligation to the citizens that we represent. Recently, there was a committee formed to explore and update the Ethics Code that exist within the city. By us not taking a positive affirmative action tonight just simply downgrades that if we do not do that. This is about ethics as well as about protections and about honesty and integrity. We have an obligation as elected officials to carry out that obligation to the citizens. I would echo Mr. Robinson's comments to vote yes to terminate him.

Ms. Cynthia Mota stated that the abuse has to stop and we do have to take a stand. We have to protect our children. It is a shame that this happened. I vote yes.

Mr. Julio Guridy stated that he feels the same sentiment that Mr. Zucal, Ms. Mota and Mr. Robinson expressed earlier. I am not going to be redundant, but I also as a member of Council and a practicing Catholic, apologize to the public, everybody, all the victims ad their family and friends that have

been suffering on the actions of some very bad people. I don't condone having people who are related to those issues in one way or another, trying to defend the Diocese or not to be associated to defend us or represent us in City Council and in the city. Mr. Zucal talked about integrity and honesty and I will stand with that as well. It is directly affecting us and would recommend my colleagues think about that and to vote yes on this motion that was brought forward.

Mr. Daryl Hendricks stated that he did not have an opportunity to read all the comments and the report. As a father of two sons and having four grandchildren there is nothing more important that we can do, but protect our children. Unfortunately, that has not happened here. He stated that he finds it particularly disturbing.

Ms. Candida Affa stated that she understands the law states that an attorney must do his best to defend his clients, but I am sure everyone of us has experienced a bad taste in our mouth sometimes. The way they do it, there is a line that you cross. Having our Solicitor in the crosshairs of this is not good for the city of Allentown. Especially since everything we have gone through for the past three years. I think it is in the best interest to vote yes, to remove him.

Mr. Roger MacLean stated that he is expecting the young lady from Temple to elaborate on some of the stuff that has been said here. In the 40 years on the Police Department I dealt with a lot of attorneys, prosecution attorneys. Some I got along with and some I didn't. Some we argued and there are a lot of people that get arrested that we may feel deep down inside that they don't deserve an attorney or their day in court, but the fact is that they do. That is part of what makes this country great. We don't always agree with those attorneys, but their job is to run the most rigorous defense that they can for the defendant. I am in no way shape or form sticking up for anybody that is accused of molesting any of these children or young people that were involved in this incident. I am saying that I believe Mr. Traud did what he felt that he had to do to represent his client which was the Diocese of Allentown. Whether we agree or we don't that's what attorneys do. He stated that he is not defending the clergy that perpetrated any of these acts. He stated that a lot of them are gone, but thinks those that are not it is just a shame that a lot of them can't be prosecuted, but he wishes that they could. He opened the discussion up to the public.

Mayor Ray O'Connell stated that Mr. Traud was acting in his role as Counsel for the Diocese. Like it or not his concern was for his client. I expect that he laid out all of the facts as he saw them and presented his clients with the best possible courses of action. Some attorneys do

criminal defense work and defend bad people. That does not make them a bad person. That is our system of justice. They listen to their clients and craft the best defense. In my opinion, and only in my opinion this is a rush to judgement in my view. I know Tom Traud is a very good attorney. A very ethical and moral individual and that he has represented this city well. He stated that he understands that Council had to do what you have to do, but Tom Traud is a very good, solid man. A good ethical man. A man of integrity. A man of character. We are very fortunate to have Mr. Traud with us for the short-term if you choose to terminate him. He stated that he wishes they not terminate Mr. Traud. This is a rush to judgement, but you have to do what you have to do and would respect Council's decision.

Mr. Courtney Robinson stated that when he contemplated doing this this morning it was solely based off of what was stated in the Grand Jury Report. However, upon further investigation today another reason came up and it is the last thing I read into the record that Attorney Traud stated to us that he discontinued litigation work for the Diocese in the year 2000. Yet, the Grand Jury has documented proof that he was working with them on litigation matters in 2002 and 2004. Quite frankly, whether it was an intentional lie or not, it was a lie to this body during the Confirmation Hearing and I don't think it was wise for us to continue with legal representation when we are not getting all of the facts straight forward and clearly from that attorney regardless of the other issues in the Grand Jury Report.

Ms. Candida Affa stated that she agrees with Mr. Robinson. Council just had a Confirmation Hearing this evening. Before Mr. Traud was up for Confirmation, it was brought up. What happens if there is any dirt that comes out from this Grand Jury investigation. We confirm or hire this man and after the investigation if there is anything that comes out and if there is any dirt out there or anyway he could be a deterrent to our city because he was involved in it. When we have these Confirmation Hearings whether we ask the questions here or we ask the questions personally while we are interviewing someone it is important for them to tell us the truth. This was something that was heavily discussed if he was involved in this. He lied to us and said no. He said that he hadn't done any ligation after 2000. When we interview people and we ask the question and with all the people out there we have to make the decision whether to hire them or not for the better of Allentown. So when they lie to us and we do confirm them and something like this comes up, it comes back at us and that is why it is so important that when we have the hearings that they tell us the truth.

Mr. Roger MacLean stated that he is hearing everybody. Why don't we do what Mayor said and not rush to judgement here and get Mr. Traud in and ask him what happened there.



Mr. Ed Zucal stated whether he did not tell us all the facts or not, the bottom-line is that he was part of a Grand Jury investigation that probably will result in some guilty pleas.

Mr. Roger MacLean stated that he understands that, but let's put things in proper context. He was representing the Dioceses. He was not involved in this in any way shape or form other than he was their attorney giving them the best advice that he could at the time.

Mr. Courtney Robinson stated that we have seen politician, movie stars, and business leaders be held accountable for actions and word that they stated to demean women 15 - 20 years ago over the past year. We have seen that happen, finally, thankfully. There is no dispute and I would argue that Attorney Traud would not dispute that he wrote these documents. These were sentiments that were said about a potential victim. In the 1980s he took crystal clear evidence that the Diocese possessed that a priest was guilty of crimes previously and there was a chance that he could commit those crimes again. He recommended instead of dealing with that priest appropriately just move them to one church to another. I don't necessarily think that you, Mr. Hendricks or Mr. Zucal would have said that about a child rapist when you were on the force and I certainly don't think that you would want a City Solicitor who would have said that to you when you were on the force. At the end of the day, I just believe that this is not the person that I want to represent me as a member of City Council. I don't want to receive legal advice on Lehigh County Authority and how we can embarrass them into settling. I don't want to receive legal advice with the Airport Authority on how we can embarrass them into settling. I want someone who represents the best of what we can achieve not the worst. That's why I think we need to vote on this tonight and send a clear message that this is not something that this body will tolerate.

Mr. Julio Guridy stated that in light of what Mr. Robinson said I thought of the same things that you said earlier. We have attorneys are they are supposed to represent their clients. You can kill somebody and you need an attorney to represent them. I started reading everything you just read, and I said to myself that I really don't feel comfortable having this person representing us. Child abuse is the most heinous crime you can see and to have graphically what the State Attorney General describes one child and what they did to them. I wouldn't want to represent or justify those issues to get someone out of jail. I just don't feel comfortable beyond that. The other issue is that Mr. Traud has an opportunity to come over here and defend himself. He is not here tonight. He knew we had a meeting and he knew we were going to talk about this. He chose not to come.

Ms. Cynthia Mota stated that as a mother of three this is horrible. I was a social worker in Reading and I had to deal with predators and to be honest with you I only lasted a week. I couldn't. We all have a moral responsibility. You have to know who you are representing and stand for something. Knowing that his clients actually did it and put other clients in danger. This is a no brainer. I think we should vote right now and vote yes.

Mr. Roger MacLean stated that unfortunately we have to open it up to the public. I want to make sure we finish with Council before we did it. He reiterated that Mr. Traud was the attorney that was defending them and as deplorable as the acts were, attorneys do defend people that do deplorable acts.

Ms. Cynthia Mota stated that they have a moral responsibility of also declining and who they choose to defend.

Mr. Roger MacLean asked if there were any comments from the public.

Ms. Grace Shawood stated that no child should ever sustain abuse. I am also a mother and advocate for children. The sentiments here are misdirected. As attorneys, and I am not one yet, but I am in my fourth year our duty is zealous advocacy for our client whoever that client is. We can't judge the person, the men and women who took positions in the public defender's office to defend child rapists, killers and drug dealers. We can't judge them for the actions of their clients. You are right, he could have declined defending or taking the Diocese as their client, but it is our duty as attorneys and advocates to make sure that everyone has equal justice and equal access to the law. Justice is blind. Everyone has the opportunity to defend themselves. Our constitution gives us the right to Counsel. That's freedom. That's liberty, justice. Attorney's should never be judged for deeds of their clients. I believe Mr. Traud and I read the entire Report and I was hurt and distraught by some of the things in that Report, but Mr. Traud was doing his job and no attorney should ever be judged for the deeds of their clients. The justice system has never worked this way and it shouldn't here tonight.

Mr. Don Ringer stated spoke about sexual abuse 60 years ago and still thinks about it every day. He stated that he was personal friends with Bishop Schlert and it's saddens me to see what happened. I took the Bishop's picture this morning and tore it up because I am so disgusted over this. Your City Solicitor Mr. Traud still should have his day that you can ask him questions.

Mr. Courtney Robinson stated that the young lady has some relevant points and is correct in a lot of ways. However, while I agree with you 100 percent

that the Constitution guarantees you the right for everyone to have an attorney. It also guarantees any client the right to hire that attorney for a reason that they feel is appropriate which is exactly what I am recommending tonight. I am not holding Mr. Traud responsible for the actions of his clients. I am holding him responsible for the words that he put down in defense of those clients, his actions. I am sitting here and hope that my fellow members of Council state this as well that those actions are unacceptable and this is not a person that I choose to represent me so I want this relationship to be terminated.

Mr. Roger MacLean asked Mr. Robinson to put things in proper perspective. He was brought up as representing the Diocese. He stated that he has six kids too and two grandchildren and I spent 40 years on the Police Department and I saw child molesters and saw people do despicable things and I always questioned how can somebody represent that person, but that's what makes our country great. The fact that they do have the representation. I had cases with Mr. Traud and he was always above board and a gentleman.

Ms. Candida Affa stated that she knows several women who have been raped and had to go to court. It is not the fact that the attorney is defending them, but disparaging the person that is there because it is the old, her skirt was short what does she expect. This is exactly what Mr. Traud was saying. She was a go-go girl. She was sexually active. Well, how many boys were molested and never once it was every brought up that he was sexually active. Being a woman, I don't feel comfortable with someone, even in the defense with an attorney that has to do, I still think that there is a line that you cross and there are so many women out there that are even afraid to go to court because what these defense attorneys will say and put them through.

Ms. Cynthia Mota stated victimizing the victim all over and over and over again. We need to take a stand. We are dealing with children.

Mr. Roger MacLean stated that he understands and agrees with that.

As a Syrian - American from Second Street in Allentown, born and raised that amplifies my pride tonight in these young ladies. I want to recognize and promote the need for continued and strong partnerships between the Allentown School District and the City of Allentown because we are producing productive future civic leaders. The fact that these three young ladies are going to Princeton University from one high school is a statistical anomaly. I challenge any one to find a single high school in the Lehigh Valley or even in the region who has three students accepted to a prestigious high institution like Princeton University. An ivy league school. From one single school. It doesn't happen. It can't happen. Dieruff High School in the Allentown School District is making things happen despite what popular beliefs may be. We are producing students who will give back to their community. Who will come back to their community. Be civic leaders and contributing members of our society which is what we need. With that, I ask you to consider continuing promoting the partnership with you and our city government and also with our community business partners to give our students more opportunities to achieve and to showcase their talents.
