Several of the funds that he speaks of proprietary etc. are actually included in the single Central Bank account. There are certain laws that it has to be separate bank accounts for that purpose. When it comes time for the CAFR, the auditors are looking very carefully at what they are showing in the Central Treasury account versus what we are show being credited to the individual funds. They can look at it from an administrative point of view. He stated that it is not convinced at this point that it is necessary under GASB principles that it has to.

Mr. Glenn Hunsicker stated that he should not be forced to do it. He should do it. It is just accounting practice that makes it more transparent.

Mr. Tom Hahn stated that because of the different comments from the different members on the Council about being the fourth largest city. Why do we have to operate on what the law states. Why can't we be better?

Mr. Roger MacLean stated the third largest.

Mr. Julio Guridy asked for clarification in terms of what we are doing in terms of the Capital Projects. We are going to use funds that we are going to take from the Risk Management or Reserve for Capital Projects and eventually float a bond to pay for it.

Mr. Brent Hartzell stated that was part of what they proposed for the General Fund which Council just approved. They have the option that the dollars that they spend this year for genuine capital expenditures that add to \$2.7 million total in the budget. If it is deemed appropriate when they go for a new bond issue down the road. The city would have an option to reimburse itself.

Mr. Julio Guridy stated that he hates to borrow more money.

Mr. Glenn Hunsicker asked about the Capital Projects and if they are going by the October, the last quarter. Is it coming out of expenditures or general obligation bonds.

Mr. Brent Hartzell stated that no bonds are being issued for this purpose in the 2020 budget. The place to look for these expenditures is the General and Civic Budget in the General Fund \$833,000 in Capital Projects. That included the Bogert's Bridget Project and money that they have to fund in the General Fund for Parks and the capital needs as a result of the Trexler Fund Agreement. The remaining items are going to be found in the Equipment Fund and there are transfers in General and Civic that move the remaining money over to the Equipment Fund. Everything that is in there for IT purposes for IT hardware. The only part of the Equipment Fund that will not be eligible as part of the Capital Expenses in which we could reimburse ourselves would be the rentals. We are renting things. Those are not capital expenditures. With Transfers the total amount comes out to \$2,723,000.
