Mr. Roger MacLean stated that if anybody is here for the Maingate issue, it has been tabled. It won't be coming up on tonight's agenda.

Mr. Kenneth Heffentrager, Allentown Tenant Association, talked about the city encouraging a housing court. A housing court is very much needed. He stated that the DA's office keeps telling them that a theft of people's property is a civil matter. It is not a civil matter. It is stolen property. He talked about the conditions of apartments and blight issues. The five year inspection is too long. There are provisions in Act 90. The city can use that and withhold their license.

Ms. Jennifer Miklas, Operation Address the Homeless - 221 N. 7th Street, stated that they are taking care of the homeless and trying to taking them out of their conditions. She stated that Mr. Guridy has a plan to get little huts. The homeless rates have been soaring. There are over 300 students in the Allentown School District that are homeless. The Hut Program is working in Seattle.

Mr. Thomas Rodriquez, Founder- Operation Address the Homeless, stated that it has been focusing on giving people the opportunity to gain quality of life back. Some people want to be there and don't want to let go of their addiction and some people have mental illness. These little huts might not be possible, but maybe something similar can happen. There is nothing in the Lehigh Valley that helps people from the beginning to end.

Mr. Ed Zucal stated that Mr. Rodriquez has been feeding the homeless for years. He stated that he has a lot of respect for him.

Mr. Julio Guridy stated that he had an opportunity to go there. There was cold food, warm food, clothing and coats. They had an opportunity to go over to tent city and experience that and they were welcoming. It can happen to any of us. He stated that we are very blessed. You are only a pay check or accident away from this happening. He stated that we as a city needs to do something. The huts are better than what they have now.

Ms. Cynthia Mota stated that Tommy's organization was one of the first organizations to be present during the fire. She thanked them and stated they worked together.

Mr. Glenn Hunsicker stated that they have been working with the city's finance department. They have a few ideas for 2020. They have to do something with the Allentown Police Department's budget and technology. They came up with an idea for more revenue for the Fire Department. Every fire in the city should be charged a fee for equipment. He suggested that the city use the \$500,000 that the city gets from the Water and Sewer Lease every year to implement a meter reading facility. He asked Mr. Glazier to implement a Pension Quarterly Written Report. It has to include the PMRS System.

Mr. Julio Guridy stated that this was an Ordinance that he introduced with unanimous support. This is something that Council has been talking about on youth and how we can help them. It is based on four principals: Love, Safety, Education, and Sustainable Employment. He stated that he went through that himself when he was in the Housing Projects in South Bethlehem. He stated that he worked after school and helped his family. Career Link can come and talk about programs for the youth. He stated that they had several meetings and the Temporary Chair and Vice Chair are Fred Montgomery and Keith Falko. Mr. Palmer is also part of it. There is going to be an amendment with 13 people.

Mr. Mike Hanlon stated that Council will pass the Ordinance and work with the Solicitor's office to tidy it up.

Mr. Julio Guridy thanked everyone that worked on the Ordinance. Everybody that will be a member of the board would have to go through the process of the city. It has to be approved by Council. Because they are working with children they will be a little more rigorous.

Mayor Ray O'Connell stated that the administration is in full support of Bill 66.

Mr. Julio Guridy encouraged his fellow Council members to support this legislation unanimously.

Mr. Courtney Robinson stated that he is confused why they will pass a law that they will fundamentally change.

Mr. Julio Guridy stated that they tried to get this done months ago. He stated that he decided to put it in, pass it and the amendments can come back. He stated that he thinks it is finished. It just needs an amendment.

Mr. Courtney Robinson asked Mr. Adam Rosenthal is that the Solicitor's Opinion is to pass a bill that they are not going to have to be complete and fix the Bill later.

Mr. Adam Rosenthal stated that he cannot confirm or deny that.

Mr. Courtney Robinson stated that if this is not finished, what is the harm of finishing it before it is voted on.

Mr. Julio Guridy stated that it was finished, brought up, but it was not put on the agenda.

Mr. Mike Hanlon stated that the Solicitor did not have time to look at the amendments. They needed to be tidied up and the thought was it should go back to committee. He thought the amendments created problems, he thought it would be better to pass the bill without the amendments.

Mr. Courtney Robinson stated to Mr. Guridy that it is irresponsible to pass legislation that you know is incomplete.

Mr. Julio Guridy stated that he doesn't think it is incomplete. It would be amended.

Mr. Courtney Robinson stated that it is the same thing. If the legislation is not complete, you need to make changes to it to complete it. He asked Mayor O'Connell will he appoint people to this board and have to reappoint them when Council comes forward at some point and make these changes.

Mayor Ray O'Connell stated that he will not appoint anyone to the board until the whole Bill 66 is an entire package.

Mr. Courtney Robinson asked what is the harm in sending this back to committee and doing it the right way.

Mr. Julio Guridy stated that there is no harm in sending it back to committee. The harm is they put it on the agenda at the next meeting. He stated that he was told that three times and it was not put on the Agenda. He stated that he is not opposed to it. It just breaks his heart that he has to keep pushing it over and over again. He has been inviting people to come here and then you don't pass it. There is always a but for our children. He stated that he rather have all of Council vote on it, then have one person not vote on it.

Mr. Roger MacLean stated that the amendment is to have the amendment brought up by the second meeting in January.

Mayor Ray O'Connell asked for a clarification. Bringing it up at the second meeting in January 15 is the package going to be done. Will the Solicitor's office have all the things that have to be questioned.

Mr. Julio Guridy stated that it is one issue. The committee recommended instead of 12 people make it 13 and have six youth from the different schools and the others are adults.

Mayor Ray O'Connell stated to vote on the amendment.

Mr. Julio Guridy wants to table it.

Mr. Courtney Robinson stated that it is a motion to table it. He supports this efforts and that's why he signed on as a co-sponsor of it. Over the last two years he has been exceptionally consistent in stating that this body should only vote of things when they have fully vetted them, fully prepared them, and made sure that they meet the city's legal requirement.

Mr. Julio Guridy stated that it is not negative. We sent this to them several weeks ago and it is not ready.

Ms. Candida Affa stated that we are legislators. We have to dot the Is and cross the Ts. If we are legislators, we have to do it right.

Mr. Julio Guridy stated that he knows Ms. Affa is for it. Right at the meeting, it is being taken out. He stated that he was made to believe that they could put it on the agenda and vote on the amendment later.

Mr. Roger MacLean asked if there were any comments from Council or the public on the motion.

Mr. Luis Perez stated that with all due respect he has been in support of this Bill. They have been at every single meeting putting it together. As adults, we can table this Bill and coe back. We have youth that will walk out of this door disappointed. They may walk out there and do drugs, pick up a gun, go join a gang, and lose all hope in us as the adults.

Mr. Courtney Robinson stated that is exactly what tabling this will do. It will establish a Committee of the Whole meeting to fix the amendment and have it brought back in a meeting in January. It is important, but thinks that the message is to do things right.

Mr. Julio Guridy stated for the record he was told to bring it and put it on the agenda and we can do the amendment. It was supposedly by the Solicitor.

Mr. Courtney Robinson stated that unfortunately there is a very bad breakdown in communication.

Mr. Adam Rosenthal stated that his understanding of the Solicitor's Opinion is that there were concerns on the amendment and ambiguity. There were concerns about the amendment that was going to be presented.

Mr. Mike Hanlon stated that the other concerns were that this meeting will turn into a Committee meeting because of the extensiveness. The amendment extended the appointment process.

Mr. Julio Guridy stated that the appointment was always done by the Mayor. He stated that he wishes would have been told by the Solicitor's office, no, don't bring it in because it is not ready.

Mr. Patrick Palmer, 617 Allen Street, stated that he has 10 students. He stated that he sent it in November 11 and at no point did someone say something was wrong with it. He asked why can't it be amended now. Based upon how long it has been, he implored Council not to table it if there is an option to amend it right now.

Mr. Julio Guridy stated that they usually do that. He doesn't know what is wrong.

Mr. Roger MacLean asked if there were any other comments from the public.

Ms. Cynthia Mota stated that everyone here wants this to happen. It is important to do things right.

Mr. Julio Guridy stated that everybody feels the same way. The information has been in the Solicitor's office since the 11th and today is the 17th.

Mr. Adam Rosenthal stated that the Bill without the amendment he doesn't think there has been any communication that is something that can't be past. It was the amendment with the change of the membership.

Mr. Courtney Robinson stated that his concern is that Council passes a law that they know they are not done with.

Mr. Matthew Kloiber stated that this is so troubling. This was supposed to be voted on tonight. The amendment was going to be dealt with later. The Solicitor's office re-drafted it to try to give it life. There were some interesting ideas proposed in it. He did not see it until two days ago. The proposals were interesting, but there was a hodgepodge put together. The email trail is pretty clear and pretty simple.

Mr. Julio Guridy asked if there idea was to vote on it tonight and correct the amendment later.

Mr. Matthew Kloiber stated that his response was a good idea. This would come here, it would be voted on and dealt with and fixed at a later point.

Mr. Julio Guridy asked if Council can bring it back over and pass it right now and do the amendment later.

Mr. Daryl Hendricks stated that Mr. Kloiber's explanation certainly adds a lot to it.

Mr. Ed Zucal asked if one of the voting members voted to table it can rescind it.

Mr. Matthew Kloiber stated that they will move to have it rescinded. He asked what Council does in the future as far as revisiting the amendment itself is not il-fated. It makes sense to do it that way if you proceed in putting it foward.

Mr. Julio Guiryd encouraged his fellow Council members to rescind the vote on it and then deal with the amendments later.

Mr. Matthew Kloiber stated that he recalls seeing this yesterday and responding to it within a few minutes with the concerns he had about it.

Mr. Mike Hanlon stated it was not put on the agenda until very late. He stated that he anticipated a committee meeting to discuss the amendment and then there was a push to put it on.

Mr. Roger MacLean suggested that Council move to Bill 77 and come back to Bill 66.

A motion was made by Courtney Robinson, seconded by Daryl Hendricks, that this Ordinance be tabled. The motion carried by the following vote:

Mr. Roger MacLean asked if there were any discussions on the Motion to Reconsider the tabling of Bill 66 from Council or the public. He asked if there were any discussions on the Bill itself.

Ms. Candida Affa stated that she did make the lecture about legislation and doing everything right, but when our Solicitor's comes up and tells us that this is OK, it is OK with me.

Mr. Courtney Robinson stated that it was also stated that the better way to do it was to send it back to committee and do it right. Since that is not going to be the option and he believes in consistency, he unfortunately has to vote no on this. He stated that he will be removing his Co-Sponsorship

of this because he doesn't believe you vote no on something that you co-sponsored. He stated that he wants to do it right and do it in a way that was responsible legislating.

Mr. Roger MacLean stated that we planted the bush. Now, we have to trim it and cultivate it.

Mr. Julio Guridy stated that he takes exception that Mr. Robinson is saying it is irresponsible.

Ms. Cynthia Mota stated that we are dealing with the youth and youth are dying. Things need to be done.

Mr. Roger MacLean stated that it keeps the ball rolling.

Mayor Ray O'Connell stated that you better hurry up.

Mr. Roger MacLean asked if there were any other comments from Council or the public.

Ms. Kanisha Cruz, Dieruff Graduate, stated that she understands where Mr. Robinson is coming from. If Council passes this, at least they see something getting done eventually. The youth is our future.

Ms. Ana Mazacolik (sp), YouthBuild Allentown, stated that the youth needs some help. The youth needs something to hold on to. They need a future, a purpose. The youth are going to be you one day. Some of the youth are going to be sitting in the chairs you are sitting in. There are youth dying everyday. She stated that she has a child and doesn't want her to grow up in this environment at all. She wants her child to have hope, resources, and outlets.

Mr. Kenneth Heffentrager stated with all due respect thousands of people voted on all of you to get the job right the first time. He does not see how one month more matters.

Mr. Patrick Palmer, 617 Allen Street, stated that he appreciates Courtney and Roger for all they have done for the citizens. He stated that he can see where Courtney is coming from. He had a lot explained to him making sure that it is done right the first time. The things that were being amended he will take ownership in that. He stated that there were a lot of things he wanted to include and against his better judgement he did not.

Mr. Courtney Robinson thanked Mr. Palmer. It is really easy not to care about process when you just want to get something done. Process

matters.

Mr. Roger MacLean stated that Mr. Palmer was not faulting your position. None of us fault your position.

Mr. Luis Perez stated that there were people in the room that emailed Mr. Robinson several times to have a follow up and did not get a response. If the process was done correctly, they would not be here. It is an embarrassment to our youth. He stated that he appreciates if they pass it and then fix it.

Mr. Courtney Robinson stated that he did not write this bill. If he did, it would have been right the first time.

Ms. April Riddick stated that she is very much involved in her community. She came to Chambers to support Oath. She stated that she is an advocate in the community for children. It is bothering her that it is taking so long to get it done and it needs to be done right. She stated that she is part of a Little League and they are self-sufficient. She suggested to the public if they really want to make this happen, do it without money.

Mr. Lewis Shupe, 814 Walnut Street, stated that he has watched all matters of legislation. When you want to amend it, you do it right here in this very room.

Mr. Julio Guridy stated that he hears all of them and we had many legislation and find out we want to amend it.

Mr. Roger MacLean asked if there were any other comments from the public.

Mr. Roger MacLean asked if there were any comments from Council or public.

Mr. Adrian Shanker, Bradbury Sullivan LGBT Community Center - 522 W. Maple Street, stated that they are very pleased that the city has included certain provisions in Vision 2030 that specifically address challenges in this city for the LGBT Community and other historically under-represented communities, especially certain provisions related to economic inclusivity and cultural diversity in our city. It is the first time that under-served communities are explicitly named in the city's plans. That is something to look forward to in a city that is much more diverse than it was a couple decades ago and encourage Council to adopt it.

Mr. Kenneth Heffentrager stated that the only thing that concerns him is the Inclusionary Zoning and the city supporting it.

Mr. Matthew Turks, 46 S. 16th Street - Lehigh Valley Economic Development Corporation, commended city planning staff on the development on an excellent plan for the future. It is ambitious. He stated that he was here and worked with the Allentown Economic Development Corporation on the development of the last Strategic Plan. The process this time around was very well managed by the entire staff. As a member

of the Steering Committee for the development of this plan is when you adopt this plan or should you adopt this plan it is your responsibility to hold the city administration to execute and to comply with the plan.

Mr. Roger MacLean asked if there were any other comments from the public.

Mr. Luis Perez commended the Community and Economic Development department on this Plan. They really involved the community and got an excellent amount of feedback from the community.
